- "Section 1. R.S. 47:841.2 is hereby enacted to read as follows:

## 11 §841.2. Youth Cessation and Prevention Fund

- 12 A. There is hereby created as a special fund in the state treasury the "Youth Cessation and Prevention Fund", hereinafter referred in this Section as the "fund". 13 After satisfying the requirements of Article VII, Section 9(B) of the Constitution of 14 15 Louisiana relative to the Bond Security and Redemption Fund and after a sufficient 16 amount is allocated from that fund to pay all of the obligations secured by the full 17 faith and credit of the state which become due and payable within any fiscal year, the 18 state treasurer shall annually deposit into the fund an amount equal to twenty percent 19 of the avails of the tax imposed pursuant to the provisions of R.S. 47:841(E).
- B. All unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund. The monies in the fund shall be invested by the state treasurer in the same manner as monies in the state general fund and all earnings on investment of monies in the fund shall be deposited into the fund.

  Monies appropriated from the fund shall be used solely as provided in Subsection C of this Section.
  - C. Subject to an annual appropriation by the legislature, monies in the fund shall be appropriated as follows:
    - (1) Forty percent to the Louisiana Cancer Research Center, established pursuant to R.S. 17:1922, to be used solely for statewide planning and funding the establishment of school, community-based, and mass-media cessation and other evidence-based initiatives to prevent and control the use of all tobacco products including but not limited to cigarettes, cigars, smokeless tobacco, smoking tobacco, vapor products, and all emerging tobacco and nicotine products by youth and young adults in schools and the community.
- 35 (2) Forty percent to the Louisiana Department of Health, office of public 36 health, Bureau of Chronic Disease Prevention and Healthcare Access, for the tobacco

24 25 26 27 28 29	D. No amount appropriated as required in this Section shall displace, replace, or supplant appropriations from the state general fund for the recipients of the fund. This shall mean that no appropriation for any fiscal year from the fund shall be made for any purpose for which a general fund appropriation was made in the previous year unless the total appropriations for the fiscal year from the state general fund for such purpose exceed general fund appropriations for the previous year.

This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval."
