AN ACT

2 To amend and reenact R.S. 37:1432(B), relative to the Louisiana Real Estate Commission; 3 to provide for the terms of appointment of commissioners; to provide for an effective 4 date; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 37:1432(B) is hereby amended and reenacted to read as follows: 7 §1432. Louisiana Real Estate Commission; qualifications; terms of office 8 9 B. Each appointment to the commission shall be for a six-year four-year 10 term. No commissioner shall serve more than one six-year term two four-year terms 11 consecutively. If an appointee has served two four-year terms consecutively as a 12 commissioner, he shall not be eligible to serve again as a commissioner until after 13 four years from the last date he served in such capacity. A commissioner shall not 14 serve more than eight consecutive years on the commission. 15 16 Section 2. This Act shall become effective upon signature by the governor or, if not 17 signed by the governor, upon expiration of the time for bills to become law without signature 18 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 19 vetoed by the governor and subsequently approved by the legislature, this Act shall become 20 effective on the day following such approval.

Abstract: Provides for the terms of appointment for commissioners of the La. Real Estate Commission.

<u>Present law</u> provides for the La. Real Estate Commission (commission). The commission is required to have 11 members from various regions of the state who are appointed by the governor. Each appointment is subject to Senate confirmation.

<u>Present law</u> provides for the terms of appointment for commissioners. <u>Present law</u> provides that each term is a six-year term. Further, <u>present law</u> provides that no commissioner can serve more than one six-year term.

<u>Proposed law</u> changes <u>present law</u> by allowing each commissioner to serve two four-year terms.

<u>Proposed law</u> provides that a commissioner is able to serve two consecutive four-year terms and then must wait four years before he is eligible again. <u>Proposed law</u> further provides that no commissioner shall serve more than eight consecutive years.

Effective upon signature of governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Commerce</u> to the original bill:

- 1. Remove proposed language that would have allowed for two six-year terms.
- 2. Add that a commissioner is able to serve two consecutive four-year terms and then must wait four years before he is eligible again.
- 3. Add that no commissioner shall serve more than eight consecutive years.
