6	1937, is comprised of three hundred fifty franchised new car and heavy truck dealers
7	operating throughout the state of Louisiana; and
8	WHEREAS, Louisiana's franchised dealers play a pivotal role in the state's economic
9	prosperity, fostering a robust marketplace that prioritizes consumer satisfaction through fair
10	and competitive pricing, fully equipped service departments staffed by expert technicians,
11	and a steadfast commitment to unparalleled customer service; and
12	WHEREAS, these dealers also contribute to maintaining high employment levels in
13	Louisiana and recognize their reliance on the state and its residents for resources, a skilled
14	workforce, and a strong business climate; and
15	WHEREAS, Louisiana's franchised dealers directly employ nearly 38,000 residents,
16	and support tens of thousands more jobs in affiliated industries, generating a payroll
17	exceeding \$1.2 billion, with average annual earnings of \$71,955; and

6	charitable organizations in the previous year alone; and
7	WHEREAS, the Louisiana Automobile Dealers Association's mission aligns with
