Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 17:1801.1(C) is hereby amended and reenacted to read as follows:

§1801.1. Hazing education; policies; new student orientation; organizations

8 * * *

C. Each organization as defined in R.S. 17:1801 shall, as a condition of operating at an institution, adopt the hazing prevention policy that the institution has adopted pursuant to Subsection A of this Section, which shall include possible institutional sanctions against the organization in the event of a reported or confirmed hazing incident, and a policy that prohibits hazing. Each organization shall provide annually at least one hour two hours of hazing prevention education that includes education relative to such policies to all members, prospective members, and anyone who is employed by or volunteers with the organization. The education may be provided in person, electronically, or both. Each organization shall submit a report annually to the institution with which it is affiliated relative to the students, employees, and volunteers receiving such education evidenced by an attestation of such individuals receiving the education. Abstract: Requires certain postsecondary education students to complete an anti-hazing course.

<u>Present law</u> (R.S. 17:1801.1), relative to hazing policies and education, requires that each new postsecondary student be provided a handbook on the dangers of and prohibition on hazing.

<u>Present law</u> further requires that certain organizations, as a condition of operating at a postsecondary education institution, annually provide hazing prevention education to its current and prospective members. <u>Proposed law</u> increases the minimum amount of time of the education <u>from</u> one hour <u>to</u> two hours.

<u>Proposed law</u> requires an institution to terminate an organization's operation on campus if it fails to comply with the hazing prevention education requirement. Further requires the institution to submit a report to the House and Senate committees on education upon such termination.

<u>Present law</u> (R.S. 17:1801) defines "organization" as a fraternity, sorority, association, corporation, order, society, corps, cooperative, club, service group, social group, band, spirit group, athletic team, or similar group whose members are primarily students at, or former students of, a postsecondary education institution in this state. Further includes the national or parent organization of which any of these underlying entities is a sanctioned or recognized member at the time of the hazing. Proposed law retains present law.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Education</u> to the original bill:

- 1. Remove requirement that a member of an organization as defined by <u>present law</u> (R.S. 17:1801) complete a one-credit hour anti-hazing course within the first two semesters of his membership.
- 2. Increase minimum amount of time that certain organizations are required to provide annual hazing prevention education to its members <u>from</u> one hour <u>to</u> two hours.
