15 On page 1, delete lines 17 through 19 and pages 2 through 3 in their entirety and insert the 16 following:

17 B. The board shall consist of ten voting members, all appointed by the 18 governor and subject to Senate confirmation as follows: 19 (1) Two members from a list of names submitted by the Louisiana State 20 Medical Society. One of the members so appointed shall practice in a parish or 21 municipality with a population of less than twenty thousand people. One member who is a physician from each of the nine administrative regions of the Louisiana 22 23 Department of Health. 24 (2) One member from a list of names submitted by the Louisiana State 25 University Health Sciences Center at New Orleans. At least every other member appointed from a list provided for in this Paragraph shall be a minority appointee. 26 27 Nothing in this Paragraph shall preclude consecutive minority appointments from 28 lists provided for in this Paragraph. One member who is a non-physician healthcare 29 professional whose profession is regulated by the board. 30 (3) One member from a list of names submitted by the Louisiana State 31 University Health Sciences Center at Shreveport. At least every other member 32 appointed from a list provided for in this Paragraph shall be a minority appointee. 33 Nothing in this Paragraph shall preclude consecutive minority appointments from 34 lists provided for in this Paragraph. 35 (4) One member from a list of names submitted by the Tulane Medical 36 School. Two members from a list submitted by the Louisiana Medical 37 (5)38 Association. 39 (6) One member from a list submitted by the Louisiana Academy of Family 40 Practice Physicians. 41 (7) One member from a list submitted by the Louisiana Hospital Association. 42 At least every other member appointed from a list provided for in this Paragraph 43 shall be a minority appointee. Nothing in this Paragraph shall preclude consecutive 44 minority appointments from lists provided for in this Paragraph.

| 20 | investigations to act as the lead investigator for any complaint regarding a physician |
| 21 | received by the board or any investigation regarding a physician initiated by the |
| 22 | board upon its own motion in accordance with R.S. 37:1285.2(A). The director of |
| 23 | investigations shall recommend disciplinary action or other appropriate response to |
| 24 | the outcome of an investigation for any licensee to the board as needed to remediate |
| 25 26 | problems, improve care, or protect the public. The director of investigations shall |
| 26 27 | serve at the pleasure of the board and be answerable directly to the board. The director of investigations shall be prohibited from concurrently serving as the |

| 33 | Section 2. R.S. 37:1263(C)(2) and (E) are hereby repealed in their entirety. |
| 34 | Section 3. The first member appointed by the governor as a non-physician healthcare |
| 35 | professional member of the Louisiana State Board of Medical Examiners shall be a |
| 36 | physician assistant who shall serve a four-year term. |

Section 4. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval."
