1 AMENDMENT NO. 1

- 2 On page 1, delete lines 2 through 11 in their entirety and insert the following:
- 3 "To amend and reenact R.S. 40:1079.1 and 1165.1(A)(1), to enact R.S.
- 4 40:1077.1(introductory paragraph), (3), and (4), and to repeal R.S. 40:1079.2, 1079.3, and
- 5 1079.13, relative to a minor's consent to certain medical procedures and treatments; to
- 6 provide for parental consent for medical procedures performed on a minor; to provide for
- 7 exceptions; to require parental access to medical records for minor children; to prohibit civil
- 8 and criminal liability for hospitals and healthcare professionals licensed to practice medicine
- 9 in this state; to repeal a school or facility's authority to provide preventive counseling or
- 10 treatment to a minor without parental consent; and to provide for related matters."

11 <u>AMENDMENT NO. 2</u>

- 12 On page 1, delete line 13 in its entirety and insert the following:
- "Section 1. R.S. 40:1079.1 and 1165.1(A)(1) are hereby amended and reenacted and

As used in this Part, the following terms shall have the following meanings:

19 * * *

(3) "Abuse" means any one of the following acts that seriously endanger the physical, mental, or emotional health, welfare, and safety of the child:

- (a) The infliction, attempted infliction, or, as a result of inadequate supervision, the allowance of the infliction or attempted infliction of physical or mental injury upon the child by a parent or any other person.
- (b) The exploitation or overwork of a child by a parent or any other person, including but not limited to commercial sexual exploitation of the child.
- (c) The involvement of the child in any sexual act with a parent or any other person, or the aiding or toleration by the parent, caretaker, or any other person of the child's involvement in any of the following:
 - (i) Any sexual act with any other person.
- (ii) Pornographic displays.
 - (iii) Any sexual activity constituting a crime under the laws of this state.
 - (d) A coerced abortion conducted upon a child.
 - (e) Female genital mutilation as defined by R.S. 14:43.4 of the child or of a sister of the child.
 - (4) "Neglect" means the refusal or unreasonable failure of a parent or caretaker to supply the child with necessary food, clothing, shelter, care, treatment, or counseling for any injury, illness, or condition of the child, as a result of which the child's physical, mental, or emotional health, welfare, and safety is substantially threatened or impaired. Neglect includes prenatal neglect. The inability of a parent or caretaker to provide for a child due to inadequate financial resources shall not, for that reason alone, be considered neglect. Whenever, in lieu of medical care, a child is being provided treatment in accordance with the tenets of a well-recognized

1	religious method of healing that has a reasonable, proven record of success, the child
2	shall not, for that reason alone, be considered to be neglected or maltreated.

4	AMENDMENT NO. 4
5	On page 1, line 20, delete "Informed consent from the" and insert the following:
6	"Except as provided for in Subsection B of this Section, consent from any
7	person lawfully exercising parental authority, including but not limited to a tutor,
8	legal guardian, or any person temporarily standing in loco parentis, whether formally
9	or informally, for a minor under his care shall be required for all medical and mental
10	health services provided to the minor until the minor reaches the age of eighteen.
11	(2) A minor may consent to medical care or the administration of medication
12	by a hospital licensed to provide hospital services or by a physician licensed to
13	practice medicine in this state for the purpose of alleviating or reducing pain,
14	discomfort, or distress of and during labor and childbirth. The manner of
15	administration of medications includes but is not limited to intravenous,
16	intramuscular, epidural, and spinal. This consent shall be valid and binding as if the
17	minor had achieved her majority, and it shall not be subject to a later disaffirmance
18	by reason of her minority."

21	Delete page 2 in its entirety and insert the following:
22	"B.(1) The consent of a spouse, parent, guardian, or any other person
23	standing in a fiduciary capacity to the minor shall not be necessary in order to
24	authorize such hospital care or services or medical or surgical care or services, or
25	administration of drugs to be provided by a physician licensed to practice medicine
26	to such a minor. A minor may consent to the provision of medical and mental health
27	services in any of the following circumstances:
28	(a) If the minor is a member of the armed forces of the United States of
29	America.
30	(b) If the minor is emancipated.
31	(c) If the minor is pregnant and consenting to medical or surgical care or
32	services related to the pregnancy.
33	(d) If the minor is seeking treatment for alcohol or substance misuse.
34	(e) If the minor is seeking medical or surgical care and services for the
35	treatment of sexually transmitted diseases.
36	(f) If the minor is donating blood.
37	(g) If the minor is seventeen years old and attending postsecondary education
38	or training.
39	(h) If the minor is exhibiting signs of abuse or neglect.
40	(2) Consent given by a minor in accordance with this Subsection shall be
41	valid and binding as if the minor had achieved his majority. Any such consent shall
42	not be subject to a later disaffirmance by reason of his minority.

47	On page 3, delete lines 13 through 22 in their entirety and insert the following:

49	healthcare provider authorized to practice medicine provide healthcare services in
50	this state shall incur civil or criminal liability in connection with any examination,
51	diagnosis and treatment authorized by this Section except for negligence.

A.(1) Each health care healthcare provider shall furnish each patient, upon request of the patient, a copy of any information related in any way to the patient which the health care healthcare provider has transmitted to any company, or any public or private agency, or any person. If the patient is a minor, each healthcare provider shall furnish the parent, tutor, or legal guardian of the minor a copy of any information related in any way to the patient which the healthcare provider has transmitted to any company, public or private agency, or person."
