Provides relative to certain pretrial procedures

<u>Current law</u> provides for rules governing first appearances, assignment of defense counsel, bail determinations, preliminary examinations, time restrictions on bills of information and indictment, examinations of witnesses, procedures governing the right to a speedy trial, and issuance and service of subpoenas. <u>Proposed law</u> provides upon a determination of a defendant's indigency, the defendant has the right to have the court appoint counsel to defend him from his initial appearance until the case's conclusion; provides that if a court determines that the arrested person is indigent, the court shall appoint qualified counsel to represent him at the preliminary examination; provides that upon motion of the state or the defendant, the transcript of the preliminary examination shall be promptly provided to the state or defense counsel.
