JUDGES: (Constitutional Amendment) Provides relative to the mandatory retirement of judges

1	A JOINT RESOLUTION
2	Proposing to amend Article V, Section 23(B) of the Constitution of Louisiana, relative to the
3	mandatory retirement of judges; to provide additional requirements for the
4	mandatory retirement of a judge; to provide that a judge shall not remain in office
5	after reaching one hundred percent of his final average compensation; to provide for
6	applicability; to provide for submission of the proposed amendment to the electors;
7	and to provide for related matters.
8	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
9	elected to each house concurring, that there shall be submitted to the electors of the state of
10	Louisiana, for their approval or rejection in the manner provided by law, a proposal to
11	amend Article V, Section 23(B) of the Constitution of Louisiana, to read as follows:
12	§23. Judges; Retirement
13	Section 23.
14	* * *
15	(B) Mandatory Retirement. (1) Except as otherwise provided in this
16	Section, a judge shall not remain in office beyond his seventieth birthday and the
17	date he attains one hundred percent of his final average compensation from the
18	judicial retirement system. A judge who attains seventy years of age and becomes
19	eligible to receive one hundred percent of his final average compensation from the

1 judicial retirement system while serving a term of office shall be allowed to complete 2 that term of office. 3 (2) The provisions of this Paragraph shall apply to all judges sworn in to the 4 office of judge on or after January 1,1997. 5 Section 2. Be it further resolved that this proposed amendment shall be submitted 6 to the electors of the state of Louisiana at the statewide election to be held on November 3. 7 2026, or at a statewide election authorized by law, whichever occurs first. 8 Section 3. Be it further resolved that on the official ballot to be used at the election, 9 there shall be printed a proposition, upon which the electors of the state shall be permitted 10 to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as 11 follows: 12 Do you support an amendment to provide that a judge sworn in to the office of judge on or after January 1,1997, shall not remain in office beyond his 13 14 seventieth birthday and after reaching his maximum retirement 15 compensation? (Amends Article V, Section 23(B))

Abstract: Provides that a judge shall not remain in office after reaching 70 years of age and his maximum retirement compensation.

<u>Present constitution</u> provides that a judge shall not remain in office beyond his 70th birthday, but also provides that he may remain in office until the completion of his term if he attains 70 years of age while serving a term of office.

<u>Proposed constitutional amendment</u> retains the <u>present constitution</u> age limitation and provides that a judge shall not remain in office after reaching 70 years of age and his maximum retirement compensation.

<u>Proposed constitutional amendment</u> applies to all judges sworn in to the office of judge on or after Jan. 1,1997.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 3, 2026, or at a statewide election authorized by law, whichever occurs first.
