AN ACT

2	To enact R.S. 46:122(B)(7) and (8), relative to the Louisiana Military Family Assistance
3	Fund; to expand the authorized expenditures of the fund to include indigent veteran
4	burials and indigent student benefits; to provide for a definition; and to provide for
5	related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 46:122(B)(7) and (8) are hereby enacted to read as follows:
8	§122. Louisiana Military Family Assistance Fund
9	* * *
10	B. The money in the fund shall be used solely for the following purposes:
11	* * *
12	(7) To pay, at the discretion of the Louisiana Military Family Assistance
13	Board, burial fees and costs for deceased indigent veterans or their spouses. For
14	purposes of this Section, indigent is defined as an individual that was receiving
15	public assistance, such as food stamps, Temporary Assistance to Needy Families,
16	Medicaid, disability insurance, residing in public housing, or earning less than two
17	hundred percent of the Federal Poverty Guideline prior to their death.
18	(8) To pay sums necessary for expenses of eligible beneficiaries under R.S.
19	29:288, as limited by the provisions of R.S. 29:289.

Abstract: Authorizes expenditures of the La. Military Family Assistance Fund to include payment for burial fees and costs for indigent veteran burials or their spouses.

<u>Present law</u> provides that money in the La. Military Family Assistance Fund shall be used solely for the following purposes:

- (1) To pay need-based claims of family members of activated military personnel or honorably discharged military personnel as authorized by the La. Military Family Assistance Board in the manner provided for in R.S. 46:123.
- (2) To provide for state administration of the program provided for in <u>present law</u> as determined by the board, not to exceed 5% of the total amount deposited into the fund each fiscal year.
- (3) To provide for the third party administrator's expenses in administration of the program provided for in <u>present law</u>, which shall not exceed 5% of the total amount deposited into the fund each fiscal year.
- (4) To pay transportation and other related costs of activated military personnel as authorized by the La. Military Family Assistance Board.
- (5) To conduct outreach activities for veterans of the U.S. Armed Forces.
- (6) To pay for educational benefits for children, spouses, and surviving spouses of veterans in accordance with R.S. 29:288.

<u>Proposed law</u> retains <u>present law</u> and further authorizes money in the fund for payment for burial fees and costs for deceased indigent veterans or their spouses and for payment of sums necessary for expenses of eligible beneficiaries under present law.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

1. Provide that payment for burial fees and costs may be paid for the spouses of deceased indigent veterans.
