Abstract: Adds members to the board of commissioners for the East Baton Rouge Parish Communications District.

<u>Present law</u> generally provides that communication districts are governed by a board composed of seven members appointed by the parish governing authority. Requires members to be qualified electors of the district. Provides that members serve four-year staggered terms.

<u>Proposed law</u> provides that the East Baton Rouge Parish Communications District shall be governed by a board of commissioners composed of nine members. Provides that the two members added by <u>proposed law</u> shall be appointed by the governing authority of East Baton Rouge Parish. Provides that the two members added by <u>proposed law</u> shall serve initial terms of four years each, and their successors shall serve four-year terms.
