Creates the Fugitive Apprehension Unit within the office of the attorney general

<u>Proposed law</u> creates the Department of Justice Fugitive Apprehension Unit; requires the Attorney General (AG) to maintain a statewide Fugitive Apprehension Unit within the investigation division of the Department of Justice, comprised of special agents who shall be P.O.S.T.- certified peace officers commissioned by the AG, intelligence analysts, and support personnel; makes the unit responsible for apprehending fugitives by coordinating with and assisting local, state, and federal law enforcement agencies, providing assistance to law enforcement agencies actively pursuing fugitives and individuals who have violated terms and conditions of court-ordered electronic monitoring, executing arrest warrants and making warrantless arrests, giving priority to proactively targeting fugitives wanted for violent felony offenses, establishing or participating in fugitive task forces with other state or other federal law enforcement agencies, and identifying, pursuing, and arresting any person harboring, concealing, or aiding a fugitive; provides that the AG shall appoint and commission special agents who shall be P.O.S.T. certified peace officers vested with all powers conferred by law upon peace officers.
