Subject to approval by the Centers for Medicare and Medicaid 10 Services, the Louisiana Department of Health shall reimburse Medicaid 11 providers for partial hospitalization program services provided to adult and geriatric patients at a licensed inpatient psychiatric hospital. The department 12 13 shall determine the appropriate reimbursement rate for the services. Such 14 reimbursement rates shall be determined as provided for by a specific 15 appropriation of funds by the legislature each year for this purpose. B. Implementation of this Section is subject to the appropriation of funds 16 17 by the legislature for this purpose.

1 Section 2. This Act shall become effective on July 1, 2025; if vetoed by the governor

and subsequently approved by the legislature, this Act shall become effective on the day

following such approval by the legislature or July 1, 2025, whichever is later.

- 2. Require the La. Dept. of Health to reimburse Medicaid providers for partial hospitalization program services provided to adult and geriatric patients at a licensed inpatient psychiatric hospital, if approved by CMS.
- 3. Require the La. Dept. of Health to determine the appropriate reimbursement rate for the services as provided for by a specific appropriation of funds by the legislature each year.
- Provide that implementation of proposed law is subject to the appropriation 4. of funds by the legislature for this purpose.
