17	"C.(1) The Louisiana Military Family Assistance Board shall have
18	the authority to issue annual grants from the Military Family Assistance Fund
10	to tax-exempt organizations established under Section $501(c)(3)$ of the
20	Internal Revenue Code, that have been in existence for at least three years.
20	The board shall consider applications only from organizations seeking to
22	improve the education, mental health, or housing needs of veterans and their
23	families. Each one-time grant shall be limited to ten thousand dollars. The
24	board's grant authority shall be cumulatively limited to one hundred thousand
25	dollars in any fiscal year.
26	(2) Applicants shall submit a specific proposal for the use of any
27	grant. Grant funds shall be used only in accordance with the project proposal
28	and budget approved by the board.
29	(3) Grant funds shall not be used as collateral, to offset other financial
30	obligations, including interest payments on lines of credit, and securing or
31	servicing debt, or to meet cash flow or general operating expenses that are
32	unrelated to the purpose of the grant proposal as defined in the grant
33	agreement letter.
34	(4) Grantees shall be required to submit a final report outlining the
35	expenditures of the grant. Grantees are required to retain account records,

1	detailing all receipts and expenditures, for a minimum of four years
2	following submission of the final grant report.
3	(5) Grantees shall repay any grant funds not used for the grant
4	purpose within thirty days of submission of the final report required by this
5	Subection.
6	(6) Grantees shall be subject to audit by the Military Family
7	Assistance Board and the legislative auditor regarding the use of grant
8	<u>funds.</u> "
