 Nothing in this Paragraph shall preclude consecutive minority appointments from
 lists provided for in this Paragraph. One member who is a non-physician healthcare
 professional whose profession has an active advisory committee with the board."

- 20 "(2)(a) The consumer non-physician healthcare professional member of the board shall possess all of the following qualifications:
 - (i) Is a citizen of the United States and has been a resident of Louisiana for at least one year immediately prior to appointment.
 - (ii) Has attained the age of majority.
 - (iii) Has never been licensed by any of the licensing boards identified in R.S. 36:259(A), nor shall he have a spouse who has ever been licensed by a board identified in R.S. 36:259(A). Has five years of experience in the practice of his profession in this state after licensure and is licensed and in good standing with the board.
 - (iv) Has never been convicted of a felony.
 - (v) Does not have and has never had a material financial interest in the healthcare profession. Has not been placed on probation by the board.
 - (b) The <u>consumer non-physician healthcare professional</u> member shall be a full voting member of the board with all rights and privileges conferred on board members, except that the <u>consumer non-physician health care</u> member shall not
