AN ACT

MENTAL HEALTH: Provides relative to victims of human trafficking

2	To enact R.S. 40:1216.2 and R.S. 46:2168.1, relative to human trafficking; to establish
3	procedures for treating victims of human trafficking; to establish the Human
4	Trafficking in Emergency Departments Advisory Board; to require the board to
5	prepare a protocol; to require the board to report to the legislature; and to provide for
6	related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 40:1216.2 is hereby enacted to read as follows:
9	§1216.2. Human trafficking; emergency department response; hospital protocols;
10	task force
11	Each of the Louisiana Department of Health's nine offices of public health
12	regions shall incorporate a regional sexual assault protocol for human trafficking as
13	a part of its annual regional sexual assault response plan. Each hospital located in
14	a particular office of a public health region shall follow its regional sexual assault
15	protocol for human trafficking.

1	Section 2. R.S. 46:2168.1 is hereby enacted to read as follows:
2	§2168.1. Louisiana Human Trafficking in Emergency Departments Task Force
3	A. The Louisiana Human Trafficking in Emergency Departments Task force
4	is hereby created within the office of human trafficking prevention.
5	B. The task force shall draft a uniform regional sexual assault protocol for
6	human trafficking which shall include information about signs of human trafficking
7	and conduct an assessment of hospital emergency department knowledge of the
8	signs of human trafficking including but not limited to the red dot process to silently
9	signal to hospital personnel that a survivor of human trafficking requests to receive
10	care and protection.
11	C. The task force shall be composed of the following members:
12	(1) The chair of the House Committee on Health and Welfare or his
13	designee.
14	(2) The director of the office of human trafficking prevention or his
15	designee.
16	(3) The chair of the of the Louisiana Human Trafficking Prevention
17	Commission or his designee.
18	(4) The co-chair of the Louisiana Human Trafficking Prevention
19	Commission or his designee.
20	(5) The chair of the Human Trafficking Prevention Commission Advisory
21	Board or his designee.
22	(6) The co-chair of the Human Trafficking Prevention Commission Advisory
23	Board or his designee.
24	(7) The secretary of the Louisiana Department of Health or his designee.
25	(8) The secretary of the Department of Children and Family Services or his
26	designee.
27	(9) The executive director of the Louisiana State Board of Nursing or his
28	designee.

1	(10) The president of the Louisiana State Coroner's Association or his
2	designee.
3	(11) A sexual assault nurse examiner selected by the Louisiana Hospital
4	Association.
5	(12) A sexual assault nurse examiner selected by the Louisiana State
6	Coroner's Association.
7	D. The chair of the House Committee on Health and Welfare or his designee
8	shall serve as the chair of the board.
9	E. The task force shall prepare and submit an annual report of its findings to
10	the governor and chairs of the House and Senate committees on health and welfare
11	no later than ninety days before the convening of the legislative session each year.

Abstract: Creates the Louisiana Human Trafficking in Emergency Departments Task Force to develop a sexual assault protocol to educate healthcare professionals on human trafficking.

<u>Proposed law</u> directs the nine office of public health regions to incorporate information about human trafficking into a regional sexual assault protocol to provide healthcare professionals and the public with information on how to spot the signs of human trafficking.

Proposed law creates the Louisiana Human Trafficking in Emergency Departments Task Force (task force).

<u>Proposed law</u> directs the task force to develop a uniform regional sexual assault protocol for human trafficking and conduct an assessment of hospital emergency departments knowledge of the signs of human trafficking.

Proposed law provides for membership of the task force.

Proposed law provides that the task force shall report to the legislature annually 90 days before session convenes and provide a report on its findings.

The Committee Amendments Proposed by House Committee on Health and Welfare to the original bill:

CODING: Words in struck through type are deletions from existing law; words underscored are additions.

- 1. Require physicians in emergency departments encountering victims of human trafficking to consult with a sexual assault nurse examiner and develop a plan of care.
- 2. Require the sexual assault regional protocol to be modified to include information about human trafficking.
- 3. Create a task force to develop a human trafficking uniform protocol and assess hospital emergency departments for knowledge on signs of human trafficking.

The House Floor Amendments to the engrossed bill:

- 1. Modify the membership of the task force.
- 2. Remove requirements relative to physicians interactions with victims of human trafficking.
