Revises Taylor Opportunity Program for Students award amounts and adds an award category for students with an ACT score of 31 or above

Present law provides for four TOPS award levels: TOPS-Tech, Opportunity, Performance, and Honors. Proposed law provides a new fifth level called "Excellence" for students scoring 31 or higher on the ACT. Present law sets Honors (ACT score of 27+) as the highest award level. Proposed law provides that Excellence (ACT score of 31+) will be the new highest level, starting with students entering college in 2025-2026. Present law provides stipends for National Guard members who qualify for TOPS. Proposed law provides an additional higher stipend for those who qualify for the new Excellence award. Proposed law adds a third academic criterion for TOPS-Tech of at least nine credit hours of early college credit attained through dual enrollment courses or equivalent validated skills and learning measures as approved by the Statewide Articulation and Transfer Council. Provides that a student qualifies for a TOPS-Tech award if he meets at least two of the three requirements provided in present law and proposed law. Authorize certain students to apply unused award amounts to medical or dental school and require repayment unless certain conditions are met.

## **EXPENDITURE EXPLANATION**

Proposed law is anticipated to increase SGF expenditures at the Board of Regents by \$3,379,202 in FY 26 and annualized in future fiscal years associated with additional TOPS awards (\$2,975,780) and medical/dental school awards (\$328,610), one-time expenses associated with programming changes for computer systems (\$71,500) and administrative costs (\$3,312). The Board of Regents projects that 844 students per year will qualify for the Excellence award under the proposed law. The total number of students receiving the award grows each year until there are 4 cohorts of 844 students, for a total of 3,376 students in FY 29 and beyond. Based on an average increased award amount of \$3,526 per student, the total payment is projected as follows:

Additionally, the Board of Regents projects that 34 students per year will qualify for the medical and dental school program provisions. The total number of students in this program grows each year until there are 4 cohorts of 34 students, for a total of 136 students in FY 29 and beyond. Based on an average award amount of \$9,665 per student, the total payment is projected as follows:

Furthermore, under the proposed law, for every 37 additional students who qualify for the TOPS-Tech program, there would be a \$100,000 annual increase in SGF. The LFO cannot determine the total impact on TOPS-Tech, because it is not known how many additional students will qualify for the TOPS-Tech award under the expanded eligibility criteria under this measure. For informational purposes, the average TOPS-Tech award amount is approximately \$2,679 per student per year.
