WILDLIFE/RESOURCES: Creates the Chronic Wasting Disease Task Force

1	A CONCURRENT RESOLUTION		
2	To create the Chronic Wasting Disease Task Force to study and recommend best practices		
3	for the management and mitigation of chronic wasting disease in the state.		
4	WHEREAS, chronic wasting disease (CWD) is a neurodegenerative disease found		
5	in most deer species (cervids), including but not limited to white-tailed deer, mule deer, elk,		
6	red deer, moose, and caribou; and		
7	WHEREAS, CWD is infectious, causes irreversible damage to brain tissue, is similar		
8	to mad cow disease in cattle, is always fatal to the cervid, and there is no treatment; and		
9	WHEREAS, CWD was first found in Louisiana in wild deer in 2022 and in captive		
10	cervid pens in 2024; and		
11	WHEREAS, not only have cervids within Louisiana tested positive for CWD, but the		
12	disease has also been found in the neighboring states of Texas, Arkansas, and Mississippi;		
13	and		
14	WHEREAS, Louisiana has already adopted certain management policies to contain		
15	the spread of CWD in Louisiana, with such policies including the establishment of control		
16	zones within which there are feeding and baiting restrictions, restrictions on the movement		
17	of deer body parts, and testing any deer harvested from within control zones for CWD, but		
18	there may be other policies and management techniques that should be evaluated; and		
19	WHEREAS, in addition the Wildlife and Fisheries Commission has adopted a rule		
20	prohibiting the importation, transportation, or possession of any cervid carcass or parts of

1	a cervid carcass, with certain exemptions for cleaned parts with no part of the spinal column		
2	or the head attached, or taxidermy mounts; and		
3	WHEREAS, many local businesses provide the food for deer feeders, bait to be		
4	placed in the woods, and mineral and salt licks; and		
5	WHEREAS, restrictions and bans on feeding deer, mineral and salt licks, and placing		
6	bait in the control area have a detrimental economic impact on these businesses; and		
7	WHEREAS, the introduction of CWD into Louisiana has the potential to be		
8	devastating to the deer hunting and breeding communities in the state and the businesses that		
9	support those activities, so all efforts to mitigate CWD and prevent its spread within the state		
10	should be investigated; and		
11	WHEREAS, a task force of experienced and interested parties could function in an		
12	advisory manner to the Department of Wildlife and Fisheries, the Department of Agriculture		
13	and Forestry, and the legislature as policies for management of CWD in Louisiana are		
14	discussed, recommended, and developed.		
15	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby		
16	create the Chronic Wasting Disease Task Force to study and recommend best practices for		
17	managing CWD and mitigating its spread within the state.		
18	BE IT FURTHER RESOLVED that the CWD Task Force shall be comprised of the		
19	following members:		
20	(A) Members representing state government shall include the following:		
21	(1) One member of the Senate appointed by the president of the Senate.		
22	(2) One member of the House of Representatives appointed by the Speaker of the		
23	House.		
24	(3) One Wildlife and Fisheries Commissioner, designated by the chairman of the		
25	commission.		
26	(4) The Department of Wildlife and Fisheries State Wildlife Veterinarian.		
27	(5) The Department of Wildlife and Fisheries Deer Program Manager.		
28	(6) The Department of Agriculture and Forestry State Veterinarian, or his designee.		
29	(B) One member shall be appointed by each of the following non-governmental

BE IT FURTHER RESOLVED that the Department of Wildlife and Fisheries shall
 staff the CWD Task Force.

BE IT FURTHER RESOLVED that the task force is charged with studying and
providing recommendations regarding, at a minimum, the following:

5 (1) Evaluating practices being used for testing and tracking in the state regarding 6 their usefulness and whether they meet the best practices recommended by the CWD 7 management and research community, including state and national agencies and partners.

8 (2) Identifying ways in which state agencies can coordinate information sharing on 9 new CWD cases in the state to provide for improved response and public notification, 10 including mapping.

(3) Identifying the level of monitoring and reporting of CWD cases in both captive
and wild herds that can provide a comprehensive look at the rate of spread and possible
source areas, or hot spots, to develop a more comprehensive response if needed.

14 (4) Identifying containment protocols for both wild and captive deer populations,
15 including those currently practiced in the state and those not being currently practiced in the
16 state.

17 (5) Evaluating existing plans, regulations, and statutes, and identification of updates
18 that may be required for regulatory measures in order to provide for effective response in
19 management of wild and captive deer populations.

BE IT FURTHER RESOLVED that the task force shall submit a report of its findings and recommendations to the House Committee on Natural Resources and Environment, the Senate Committee on Natural Resources, the House Committee on Agriculture, Forestry, Aquaculture, and Rural Development, and the Senate Committee on Agriculture, Forestry, Aquaculture, and Rural Development before the commencement of the 2027 Regular Session of the Legislature of Louisiana.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to each
task force member, or organization charged with appointing a member of the task force.
