HOUSE RESOLUTION NO. 241

BY REPRESENTATIVE FREIBERG

PUBLIC ASSISTANCE: Requests the Louisiana legislative auditor to publish an updated report of integrating assistance programs to achieve improved outcomes

1 A RESOLUTION

2 To urge and request the Louisiana legislative auditor to review assistance programs and  
3 update the report issued on February 20, 2024, relative to the integration of such  
4 programs for the purpose of achieving improved outcomes.

5 WHEREAS, House Resolution No. 100 of the 2023 Regular Session of the  
6 Legislature urged and requested the Louisiana legislative auditor to conduct an appropriate  
7 audit or evaluation of assistance programs in this state to evaluate participation, costs, and  
8 outcomes for each program and identify areas for improved coordination, including the  
9 Supplemental Nutrition Assistance Program (SNAP), Supplemental Nutrition Assistance  
10 Program Employment and Training initiative (SNAP E&T), Workforce Innovation and  
11 Opportunity Act (WIOA), Temporary Assistance for Needy Families program (TANF),  
12 Child Care Assistance Program (CCAP), unemployment insurance program, and any other  
13 block grant and assistance programs the legislative auditor deemed necessary to include; and

14 WHEREAS, on February 20, 2024, the legislative auditor published an informational  
15 report titled, "Coordination of Public Assistance and Workforce Development Programs";  
16 and

17 WHEREAS, the report found that in 2023, Louisiana spent approximately three  
18 billion, two hundred million dollars, primarily in federal dollars, on the following programs:

- 19 (1) Supplemental Nutrition Assistance Program (SNAP)  
20 (2) SNAP Employment & Training Initiative (SNAP E&T)  
21 (3) Temporary Assistance for Needy Families (TANF) cash assistance

1 (4) Workforce Innovation and Opportunity Act (WIOA)

2 (5) State Unemployment Insurance (UI) Program

3 (6) Reemployment Services and Eligibility Assessment (RESEA) Program

4 (7) Child Care Assistance Program (CCAP); and

5 WHEREAS, these programs served approximately one million individuals; and

6 WHEREAS, the report included the following findings and recommendations:

7 (1) "We found that while Louisiana has a unified WIOA state plan, it needs more  
8 collaboration among agencies and stakeholders to put together a unified vision and plan  
9 detailing how best to coordinate and administer public assistance and workforce  
10 development programs. The governor and cabinet-level leadership would need to take the  
11 lead in spurring improved coordination among these programs."

12 (2) "In addition, we found that other states have varying levels of coordination  
13 among their agencies and programs. In Louisiana, potential strategies for improved  
14 coordination could include increased public information and data and/or document sharing.  
15 For example, several other states have websites that include a clear picture of available  
16 services and how to apply."

17 (3) "We also found that measuring outcomes could help Louisiana determine which  
18 programs and which contractors and providers are the most effective in meeting their goals.  
19 Such information could help state leaders make more informed decisions about resources  
20 and funding"; and

21 WHEREAS, on March 22, 2024, Governor Jeff Landry established through executive  
22 order the Louisiana Workforce and Social Services (LA WASS) Reform Task Force to  
23 "conduct research and collect data on state models for coordinating and fully integrating  
24 workforce, social services, education, child care, and health care programs and develop  
25 alternative approaches that Louisiana should consider to achieve improved outcomes"; and

26 WHEREAS, the LA WASS Reform Task Force published its report and  
27 recommendations on February 7, 2025, and Governor Landry, his cabinet, and members of  
28 the Louisiana Legislature have been diligently working with task force members and  
29 stakeholders to develop a plan to improve the efficacy of workforce and social services  
30 through the integration of such programs and improved service delivery focused on

1 supporting individuals to effectively transition from poverty and dependence to  
2 independence and self-sufficiency; and

3 WHEREAS, legislation was introduced in the 2025 Regular Session of the  
4 Legislature as House Bill No. 624 and House Bill No. 617 to implement the task force's  
5 recommendations and make significant progress toward the vision of an effective "One  
6 Door" model to benefit Louisianans in need and to boost the state's workforce and economic  
7 competitiveness.

8 THEREFORE, BE IT RESOLVED that, if House Bill No. 624 and House Bill  
9 No. 617 of the 2025 Regular Session are enacted, the House of Representatives of the  
10 Legislature of Louisiana does hereby urge and request the legislative auditor to conduct a  
11 follow-up review of its February 20, 2024, report and publish an updated report no later than  
12 thirty days prior to the 2027 Regular Session.

13 BE IT FURTHER RESOLVED that, if House Bill No. 624 and House Bill No. 617  
14 of the 2025 Regular Session are not enacted, a follow-up review of the February 20, 2024,  
15 audit would include a review of workloads that can be integrated regardless of statutory  
16 changes and identify limitations on integration.

17 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the  
18 Louisiana legislative auditor, the governor, and each member of the Louisiana Workforce  
19 And Social Services Reform Task Force.
