AGRICULTURE: Memorializes Congress and the United States Department of Agriculture to reinstate and fund the Local Food Purchase Assistance Cooperative Agreement Program

A CONCURRENT RESOLUTION

2	To memorialize the United States Congress and the United States Department of Agriculture
3	to reinstate and fund the Local Food Purchase Assistance Cooperative Agreement
4	Program to support Louisiana farmers, strengthen community-based food systems,
5	and expand access to fresh, locally grown food for underserved populations.
6	WHEREAS, the United States Department of Agriculture's Local Food Purchase
7	Assistance Cooperative Agreement Program (LFPA) was created to support local and
8	regional food systems by providing states with funding to purchase food from socially
9	disadvantaged farmers, ranchers, and producers for distribution through nonprofit
10	organizations, food banks, and other community feeding efforts; and
11	WHEREAS, the LFPA brought more than twelve million dollars to Louisiana,
12	boosting local agriculture and ensuring that fresh, healthy food reached families in need
13	through trusted distribution partners such as food banks and community-based organizations;
14	and
15	WHEREAS, the program enabled new and expanded market access for small and
16	historically underserved farmers in Louisiana, building stronger local supply chains and
17	contributing to rural economic development; and
18	WHEREAS, the LFPA fostered innovative partnerships between farmers, food hubs,
19	tribal entities, and hunger relief organizations to deliver culturally appropriate and nutritious
20	foods to communities facing food insecurity; and

1	WHEREAS, there are five regional food banks that make up the Feeding Louisiana
2	network which includes the Second Harvest Food Bank of Greater New Orleans and
3	Acadiana, the Greater Baton Rouge Food Bank, the Food Bank of Central Louisiana, the
4	Food Bank of Northeast Louisiana, and the Food Bank of Northwest Louisiana; and
5	WHEREAS, each of the five regional food banks has played a pivotal role in
6	implementing the LFPA program by building new markets for local farmers and ensuring
7	the consistent distribution of fresh, locally sourced food to communities across the state; and
8	WHEREAS, the sudden and premature termination of the LFPA program by the
9	United States Department of Agriculture has jeopardized the progress made in strengthening
10	Louisiana's local food system, disrupted purchasing commitments with farmers, and
11	diminished the ability of food banks and nonprofits to offer healthy food options to
12	vulnerable populations; and
13	WHEREAS, restoring and fully funding the LFPA program aligns with national
14	goals to invest in local agriculture, address food insecurity, promote racial and economic
15	equity, and improve public health through increased access to unprocessed, nutrient-rich
16	foods; and
17	WHEREAS, long-term investment in programs like the LFPA is essential to building
18	a more resilient, equitable, and sustainable food system in Louisiana and across the nation.
19	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
20	memorialize the United States Congress and the United States Department of Agriculture
21	to reinstate and provide long-term funding for the Local Food Purchase Assistance
22	Cooperative Agreement Program to support Louisiana farmers, strengthen community-based
23	food systems, and expand access to fresh, locally grown food for underserved populations.
24	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
25	president of the United States, the secretary of the United States Department of Agriculture,
26	and each member of the Louisiana congressional delegation.
