Provides for academic transparency and parental access to digital instructional materials and other educational materials in a manner that is free-of-charge. (8/1/25)

Proposed legislation amends present law concerning parental review of student instructional materials, requiring local school boards to develop rules and policies to make certain instructional materials available for online review at no cost. Further specifies reasonable hours for in-person review are to be included in policies. Permits parents to make a copy of instructional materials via personal mobile or other device. Amends the definition of "instructional materials" to remove nonsecure tests and assessments; however, provides nonsecure test and assessment answer keys may be shown to the parents at the discretion of the local school board and may include only in-person viewing at the school. Requires each local school board to submit an electronic copy or a digital link to rules and policies adopted due to proposed legislation to the Louisiana Department of Education (LDOE) and directs the department, before March 9, 2026, to compile and submit the information received to the Senate and House education committees, including a copy of each policy and any fee schedule related to school-supplied physical copies of instructional materials.
