MEDICAID: Memorializes congress and urge the Centers of Medicare and Medicaid Services to increase pay rates for direct care support workers

A CONCURRENT RESOLUTION

2	To memorialize the United States Congress and urge the Centers of Medicare and Medicaid
3	Services to increase pay rates for direct care support workers.
4	WHEREAS, direct care support workers (DCSWs) such as nursing assistants, home
5	health aides, and personal care aides provide essential services to individuals with
6	disabilities, the elderly, and other vulnerable populations in inpatient care facilities, home
7	care settings, and community-based programs; and
8	WHEREAS, DCSWs play a critical role in ensuring the health, safety, and well-being
9	of those they serve often providing assistance with daily living activities, medical care, and
0	emotional support; and
1	WHEREAS, despite the essential nature of their work, DCSWs are significantly
12	underpaid, leading to high turnover rates, staffing shortages, and compromised care quality;
13	and
4	WHEREAS, in 2020, the average hourly rate for DCSWs in Louisiana was
15	approximately nine dollars per hour; and
16	WHEREAS, the demand for DCSWs continues to rise due to an aging population and
17	increasing needs for long-term support services; and
18	WHEREAS, inadequate pay has led to a workforce crisis, reducing the availability
9	of qualified professionals and increasing strain on existing caregivers; and
20	WHEREAS, increased wages would improve workforce retention, enhance the
21	quality of care, and provide economic stability for these essential workers; and

1 WHEREAS, the Louisiana Legislature, in partnership with the Louisiana Department 2 of Health, has taken steps to increase wages for DCSWs and meet the need for quality care 3 for one of this state's most vulnerable populations; and 4 WHEREAS, federal programs such as Medicaid and Medicare set reimbursement 5 rates that directly impact the wages of DCSWs, and federal action is needed to ensure 6 adequate funding for increased pay. 7 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 8 memorialize the United States Congress and urge federal agencies, including the Centers for 9 Medicare and Medicaid Services, to revise reimbursement structures, and implement higher 10 wages for DCSWs; and 11 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 12 presiding officers of the Senate and the House Representatives of the Congress of the United 13 States of America, each member of the Louisiana congressional delegation, the secretary of 14 the United States Department of Health and Human Services, and administrator for the 15 Centers for Medicare and Medicaid Services.
