HOUSE CONCURRENT RESOLUTION NO. 73

PHARMACIES: Memorializes the United States Congress to take action relative to the use of pharmacy benefit managers and their impact on the citizens of this state

A CONCURRENT RESOLUTION

2	To memorialize the United States Congress to take action to limit the harmful impacts and	
3	practices of pharmacy benefit managers (PBMs) and protect the citizens of this state.	
4	WHEREAS, pharmacy benefit managers (PBMs) are third-party entities that manage	
5	prescription drug benefits on behalf of health insurers, employers, and government programs	
6	that have significant control over the pricing, availability, and distribution of prescription	
7	medications; and	
8	WHEREAS, PBMs are responsible for negotiating drug prices and establishing	
9	formularies that influence the cost and accessibility of medications for patients in this state	
10	where many individuals rely on Medicaid and other programs that PBMs are responsible for	
11	managing; and	
12	WHEREAS, numerous studies and reports have raised concerns about the	
13	contributing role of PBMs toward rising drug costs, lack of transparency in pricing, and the	
14	imposition of restrictive formularies that limit patient access to necessary medications; and	
15	WHEREAS, the lack of transparency in PBM practices often leads to higher	
16	out-of-pocket costs for patients, especially those in underserved communities, and	
17	disproportionately affects residents of this state particularly seniors, low-income families	
18	and individuals with chronic health conditions; and	
19	WHEREAS, this state has long been committed to improving access to affordable	
20	healthcare for its residents, and the state has a vested interest in ensuring that any entities	

1	involved in healthcare delivery, including PBMs, operate in a way that prioritizes the		
2	well-being of its citizens; and		
3	WHEREAS, legislation has been proposed in congress to increase transparency		
4	accountability, and regulation of PBMs and to ensure that PBMs are held to high standards		
5	that protect consumers from unfair practices; and		
6	WHEREAS, Louisiana's leadership in healthcare reform can have a profound impac		
7	on shaping national policy, and it is essential for our congressional delegation to act in the		
8	best interest of the residents of this state to mitigate the harmful effects of PBM practices.		
9	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby		
10	urge and request the United States Congress to take immediate action to address the harmful		
11	practices of pharmacy benefit managers by:		
12	(1)	Increasing transparency in PBM operations, including detailed reporting of	
13		pricing negotiations, rebates, and fees paid to PBMs by drug manufacturers,	
14		insurers, and other entities.	
15	(2)	Requiring PBMs to pass along the savings from rebates and discounts to	
16		consumers, ensuring that patients benefit directly from any negotiated cost	
17		reductions.	
18	(3)	Regulating PBM business practices to prevent anti-competitive behavior,	
19		such as steering patients to higher-cost drugs or limiting access to	
20		medications that are medically necessary.	
21	(4)	Implementing measures to enhance oversight of PBM practices and ensuring	
22		they align with the best interests of consumers especially those in vulnerable	
23		populations such as the elderly and individuals with chronic conditions.	
24	(5)	Supporting legislation that holds PBMs accountable for any harm caused to	
25		patients, including restrictions on the use of prior authorization processes that	
26		delay access to necessary prescriptions.	
27	BE IT	FURTHER RESOLVED that the Legislature of Louisiana urges all members	
28	of Louisiana's congressional delegation to advocate for reform and support legislation aimed		
29	at addressing the harmful effects of PBM practices on the citizens of this state and the nation		
30	as a whole.
