1 A RESOLUTION

2 To commend Corporal Rickey Anderson of the Caddo Parish Sheriff's Office on being  
3 named 2025 Deputy of the Year by the Louisiana Sheriffs' Association.

4 WHEREAS, Louisiana Sheriff's Association President Sheriff K.P. Gibson and the  
5 Louisiana Sheriff's Association Awards Committee has selected DEA Task Force Officer  
6 Corporal Rickey Anderson as the recipient of the 2025 Deputy of the Year Award; and

7 WHEREAS, the Deputy of the Year Award seeks to recognize a deputy sheriff who  
8 has shown unusual initiative and imagination in the performance of his or her duty and who  
9 has worked to improve the quality of life in the community; Corporal Anderson spearheaded  
10 a 2021 investigation that, as a result of his persistence and selfless investigative work on  
11 behalf of the victim and his family, ultimately led to multiple arrests and a major milestone  
12 for both the Western District of Louisiana and the United States; and

13 WHEREAS, Corporal Anderson has worked with the Caddo Parish Sheriff's Office  
14 (CPSO) since 1993; his work during the 2021 investigation allowed the CPSO to secure the  
15 first-ever federal convictions for the distribution of fentanyl resulting in death and helped  
16 establish a legal precedent in the fight against the distribution of fentanyl in Louisiana; he  
17 is truly most deserving of the highest recognition for his incredible service to the state.

18 THEREFORE, BE IT RESOLVED that the House of Representatives of the  
19 Legislature of Louisiana does hereby commend Corporal Rickey Anderson of the Caddo  
20 Parish Sheriff's Office on being named 2025 Deputy of the Year by the Louisiana Sheriffs'

1 Association and does hereby extend enduring appreciation for his incredible service to the  
2 state and its citizens.
