TRAFFIC. To direct the Louisiana Department of Transportation and Development to conduct a study and report on road hazards on state highways and their impact on Louisiana residents.

2	To direct the Louisiana Department of Transportation and Development to conduct a study
3	and report on road hazards on state highways, their impact on Louisiana residents,
4	and develop practical policy recommendations.
5	WHEREAS, the Louisiana Department of Transportation and Development (DOTD)
6	is charged with the maintenance and improvement of over 16,000 miles of state-owned
7	roadways, including responsibility for addressing road hazards such as potholes, damaged
8	signage, debris, and deteriorating infrastructure; and
9	WHEREAS, road hazards can be considered a threat to public safety, a contributor
10	to vehicular damage, and a significant financial burden for Louisiana families and
11	businesses; and
12	WHEREAS, damage from road hazards such as potholes, may leave drivers and
13	low-income residents without recourse or protection; and
14	WHEREAS, the Department of Transportation and Development has legal staff
15	dedicated to the assessment and litigation of damage claims sustained on state highways; and
16	WHEREAS, data on claims, settlement and litigation payouts, and repair response
17	times to hazardous roads that cause damage to citizens should be readily transparent to the
18	public or policymakers; and

- 1 WHEREAS, other states, including New York, California, and Florida, have adopted 2 a range of legal, administrative, and fiscal approaches to road hazard claims and prevention, 3 such as mandatory reporting systems, dedicated funding streams, lower liability thresholds, 4 and innovative road user fee programs; and WHEREAS, Louisiana would benefit from evaluating such national best practices 5 to enhance its own policies, funding strategies, and public accountability mechanisms; and 6 7 WHEREAS, addressing road hazards efficiently and equitably is not only a matter 8 of infrastructure maintenance but also a critical factor in advancing public safety, economic 9 productivity, and citizens' quality of life. THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana 10 11 does hereby direct the Louisiana Department of Transportation and Development to conduct 12 a comprehensive review and a report of other states and national best practices in 13 comparison to the department's current process to include all of the following: 14 (1) Access road hazard management practices, including maintenance protocols, 15 reporting systems, and average response times for damage claims. 16 (2) Compile and report data on the number of citizen claims filed for road hazard-related damages, the number of claims approved or denied, the total and average 17 18 payout amounts, and the reasons for denials. 19 (3) Assess the financial and quality-of-life burdens caused by road hazards on Louisiana residents, particularly lower-income and rural communities. 20 (4) Review relevant statutes and policies regarding liability, insurance coverage, and 21 22 sovereign immunity related to road hazard damages. (5) Examine models and programs from other states that offer improved claim 23 24 processes, alternative funding mechanisms, or streamlined hazard reporting systems. 25 BE IT FURTHER RESOLVED that the DOTD shall develop policy recommendations for improving road hazard mitigation and compensation procedures, to be 26 27 submitted in a report to the Senate Committee on Transportation, Highways and Public Works and to the David R. Poynter Legislative Research Library, as required by R.S. 24:771, 28 no later than February 1, 2026. 29
