2	To amend and reenact R.S. 46:440.1(B) through (E), relative to the Medical Assistance
3	Programs Fraud Detection Fund; to provide for the dedication of certain revenues
4	and for the deposit and use of monies in the fund; to limit the amount of monies in
5	the fund; to provide for the allocation of monies from the fund; to provide for an
6	effective date; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 46:440.1(B) through (E) are hereby amended and reenacted to read
9	as follows:
10	§440.1. Medical Assistance Programs Fraud Detection Fund

12	B. After compliance with the requirements of Article VII, Section 9(B) of the
13	Constitution of Louisiana relative to the Bond Security and Redemption Fund, and
14	prior to monies being placed in the state general fund, all monies received by the any
15	state entity related to a recovery, fine, or penalty pertaining to the medical
16	assistance programs, including all monetary sanctions assessed against
17	providers and managed care organizations, after accounting for any federal
18	share, and excluding any third party liability and estate recoveries as defined
19	by federal regulation, pursuant to a civil award granted or settlement under the
20	provisions of this Part, except for the amount to make the medical assistance
21	programs whole, shall be deposited into the fund.
