(Constitutional Amendment) Provides for legislative term limits

Proposed constitutional amendment provides that a term-limited member of the Louisiana Senate or member of the Louisiana House of Representatives shall not qualify for election to the Senate for 10 years following the end of his third consecutive term. To be submitted to the electors at the statewide election to be held on November 3, 2026.

**EXPENDITURE EXPLANATION**


In certain circumstances, the Secretary of State may incur minimal ballot processing costs associated with this measure. As a regular practice, the department budgets for up to 10 constitutional amendments and statewide propositions for the fall statewide elections. To the extent the ballot includes more than 10 constitutional amendments and statewide propositions, the Secretary of State may require additional SGF resources for the 11/03/26 statewide election. Any expenditure impact would be realized in FY 27.
