AMENDMENT NO. 1

On page 1, line 2, after "paragraph) and" delete the remainder of the line and delete line 3 in its entirety and insert the following:

"(a) and (3) and to repeal R.S. 11:2260(A)(2)(b), relative to the"

AMENDMENT NO. 2

On page 1, line 5, after "of trustees;" delete "to provide for term limits;"

AMENDMENT NO. 3

On page 1, line 6, after "board of trustees;" and before "and to" insert "to provide for effectiveness;"

AMENDMENT NO. 4

On page 1, line 12, after "paragraph) and" delete the remainder of the line and delete lines 13 and 14 in their entirety and insert the following:

"(a) and (3) are hereby amended and reenacted to read as follows:"

On page 1, line 19, after "(a)" delete "Two" and insert "Five"

AMENDMENT NO. 6

On page 2, line 2, after "by" and before "members" insert "active"

AMENDMENT NO. 7

On page 2, delete lines 3 through 7 in their entirety and insert the following:

~~(i) One member shall be elected in December, 1988, to take office January 1, 1989, to serve until January 1, 1992, and his successor shall be elected for a term of five years, commencing on January 1, 1992. Three members shall be active members of the Professional Fire Fighters Association.~~

~~(ii) One member shall be elected in December, 1988, to take office January 1, 1989, to serve until January 1, 1993, and his successor shall be elected for a term of five years, commencing on January 1, 1993. Two members shall be active members of the system not participating in the Professional Fire Fighters Association."~~

AMENDMENT NO. 8

On page 2, at the beginning of line 9, delete "(3)(a)" and insert "(3)"

AMENDMENT NO. 9

On page 2, line 21, after "Section" delete the comma "," and delete the remainder of the line and delete lines 22 through 27 in their entirety and insert a period "."

1 AMENDMENT NO. 10

2 On page 3, delete lines 1 and 2, and insert the following:

3 "Section 2. R.S. 11:2260(A)(2)(b) is hereby repealed in its entirety.

4 Section 3. The terms of the members of the board of trustees of the Firefighters'
5 Retirement System elected prior to the effective date of this Act pursuant to R.S.
6 11:2260(A)(2)(a) and (b) shall terminate on the effective date of this Act; however, such
7 members shall remain in office until the board members are elected as provided in this Act
8 and take office.

9 Section 4. This Act shall become effective upon signature by the governor or, if not
10 signed by the governor, upon expiration of the time for bills to become law without signature
11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
12 vetoed by the governor and subsequently approved by the legislature, this Act shall become
13 effective on the day following such approval."
