 4 330.1(C)(1)(b)(iii), 330.3(A), (B)(1), and (C)(1), and 330.10(A), relative to the Southeast  
 5 Louisiana Flood Protection Authority- West Bank and Lafitte Area Independent Levee  
 6 District; to provide for renaming the Lafitte Area "

7 AMENDMENT NO. 2

8 On page 1 line 14 after "38:291(Y)," delete the remainder of the line and delete lines 15 and  
 9 16 and insert the following: "330.1(B)(2)(a), the introductory paragraph of 330.1(C)(1)(b),  
 10 330.1(C)(1)(b)(iii), 330.3(A), (B)(1), and (C)(1), and 330.10(A) are hereby amended and  
 11 reenacted to read as follows:"
