Establishes the Louisiana Statewide Data Exchange Compact. (gov sig)

Proposed law authorizes the Office of Technology Services (OTS) to create the Louisiana Statewide Data Exchange Compact, defined as a legal and technical framework for secure, privacy-compliant interagency data sharing between OTS and state agencies. Proposed law designates OTS as the compact administrator and requires OTS to establish a committee of participating agencies that shall provide input on the establishment of the template of the compact, advise the office on the compact, review the compact at least biannually to correspond with any changes to state and federal laws and the evolving data security landscape, and review any rules promulgated by OTS pursuant to proposed law. Proposed law specifies that use of the compact by an agency is voluntary and each participating agency may amend or terminate the compact or pursue an alternate approach to protecting data shared by the agency. Proposed law provides that the compact must require a receiving agency to safeguard confidential data. Proposed law provides that OTS shall not acquire any ownership rights or interest in data shared pursuant to the compact. Effective upon governor's signature.
