Amendments proposed by Representative Cox to Engrossed House Bill No. 750 by Representative Cox

1 AMENDMENT NO. 1

2 On page 1, line 7, after "penalty;" and before "and" insert "to provide for an effective date;"

3 AMENDMENT NO. 2

4 On page 2, delete lines 21 through 23 in their entirety and insert in lieu thereof the following:

5 "(b) "Clear and conspicuous" or "clearly and conspicuously" does not
6 include disclosures that interfere with, detract from, or contain information that
7 contradicts the negative option"

8 AMENDMENT NO. 3

9 On page 4, delete lines 1 through 4 in their entirety and insert in lieu thereof the following:

10 "(4) Includes any information that contradicts or undermines the consumer's
11 ability to provide express affirmative"

12 AMENDMENT NO. 4

13 On page 4, line 6, change "(6)" to "(5)"

14 AMENDMENT NO. 5

15 On page 4, delete line 8 in its entirety and insert in lieu thereof "date of formation of the
16 contract."

17 AMENDMENT NO. 6

18 On page 4, line 9, change "(7)" to "(6)"

19 AMENDMENT NO. 7

20 On page 4, delete lines 18 through 22 in their entirety and insert in lieu thereof the following:

21 "(d) One or more methods for the consumer to cancel the automatic renewal
22 or continuous service."

23 AMENDMENT NO. 8

24 On page 4, line 23, change "(f)" to "(e)"

25 AMENDMENT NO. 9

26 On page 4, delete line 25 in its entirety and insert in lieu thereof the following:

1 "(7) Fails to provide a cost-effective, timely, and easy-to-use mechanism for
2 the"

3 AMENDMENT NO. 10

4 On page 4, line 27, change "any recurring charges" to "future charges after the expiration of
5 the contractual term"

6 AMENDMENT NO. 11

7 On page 5, delete lines 9 through 20 in their entirety

8 AMENDMENT NO. 12

9 On page 5, line 21, change "D." to "C."

10 AMENDMENT NO. 13

11 On page 6, line 2, change "fifteen" to "three"

12 AMENDMENT NO. 14

13 On page 6, line 7, change "E." to "D."

14 AMENDMENT NO. 15

15 On page 6, delete line 13 in its entirety and insert in lieu thereof the following:

16 "E. This Chapter does not apply to any of the following:"

17 AMENDMENT NO. 16

18 On page 6, between lines 26 and 27, insert the following:

19 "(6) A service provided by a business or its affiliate when either that
20 business or its affiliate is regulated by the Federal Communications Commission."

21 AMENDMENT NO. 17

22 On page 7, after line 13, add the following:

23 "Section 2. This Act shall become effective on January 1, 2027."
