(17) The right to attend and have transportation to services, events, and activities provided by the Independent Living Skills Program within the youth's child's region, the right to receive timely notification of upcoming youth child advocacy and engagement services in the youth's child's region, and the right to be provided with the entire amount of the monthly allowance as outlined in department policy.

(18) The right to express and voice the youth's child's needs, concerns, and desires about foster care."
