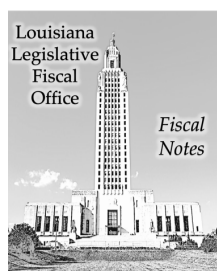

Provides relative to waivers under the Workforce Innovation and Opportunity Act

Present law allows the department to use an amount not to exceed 20% of the amount of funds available to the department for workforce training and services to implement state level responsibilities.

Proposed law creates the Transition Advisory Team and provides for the functions and membership of the team, as well as a sunset provision for the team. Proposed law authorizes the secretary of Louisiana Works (LA Works) to design and implement a workforce system planning process consistent with the Workforce Innovation and Opportunity Act (WIAO) of 2014 and to the extent allowed by federal law or approved federal waiver. Proposed law requires LA Works to establish a formal consultation process with local workforce development partners regarding allocation and expenditure of workforce funds.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

Proposed law creates directs Louisiana Works (LA Works) to design and implement a unified statewide workforce system, focused on comprehensive statewide planning, and directs LA Works to pursue additional federal waiver authority from the U.S. Department of Labor’s Employment and Training Administration. Proposed law creates a Transition Advisory Team to advise LA Works throughout the planning process. LA Works will be required to establish a formal process for meaningful consultation with local workforce partners and employers to ensure that that funding decisions reflect regional market needs, employer needs, and workforce priorities.

LA Works reports that the functions in this bill are already within the scope of of responsibilities performed by the Office of Workforce Development as part of its administration of the state’s Workforce Innovation and Opportunity Act program. LA Works believes that the provisions of this bill can be implemented with current resources, and implementation will have no fiscal impact on the agency’s budget.

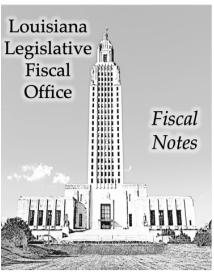
