23 caused damage to underground utilities or facilities and was at fault for such
24 damage, including failure to comply with the Louisiana Underground Utilities
25 and Facilities Damage Prevention Law, R.S. 40:1749.11 et seq.

26 (b) The office may require documentation of repairs, reimbursement of
27 damages, corrective action plans, utility coordination records, locate requests,
28 or other compliance measures prior to the release of withheld funds."
