MEDICAID MANAGED CARE EN NO IMPACT See Note
Provides relative to Medicaid coverage for pregnant women

Present law provides Medicaid coverage for continuous glucose monitoring for LA Medicaid enrollees who require insulin more than two times daily or evidence of level two or level three hypoglycemia.

Proposed law amends the present law to provide Medicaid coverage for a continuous glucose monitor for a Medicaid enrollee who has any type of diabetes, including but not limited to gestational diabetes, requiring use of insulin or evidence of level two or level three hypoglycemia.
