 Provides relative to the number of assistant district attorneys in each judicial district

Current law provides for the number of assistant district attorneys in the 42 judicial districts within the state (624). Proposed law increases the number of assistant district attorneys in the judicial districts of the state by a total of 60 assistant district attorneys statewide; provides that the change shall become effective when an Act of the Louisiana Legislature containing a specific appropriation of monies for its implementation becomes effective; provides that in accordance with the Governor's Advisory and Review Commission on Assistant District Attorneys, any additional changes in the number of assistant district attorneys not approved by the Governor's Advisory and Review Commission on 4/12/26, shall become effective upon recommendation by the commission that such additional assistant district attorneys satisfy the applicable guidelines in its report to the governor and legislature; provides that the Act of the legislature containing a specific appropriation of monies for the implementation of the proposed law shall become effective upon signature by the governor, or if not signed by the governor, upon expiration of time for bills to become law without signature of the governor.

EXPENDITURE EXPLANATION

Proposed law will result in an increase of \$3.4 M in SGF expenditures in FY 27 and subsequent fiscal years for an increase of a total of 60 assistant district attorneys (ADAs) statewide. The corresponding increase is associated with an increase in salaries (\$3,000,000) and related benefits (\$411,000) as follows:

The provisions of proposed legislation are effective when an Act of the Louisiana Legislature containing a specific appropriation of monies for implementation becomes effective.

Note: HB 1 of the 2026 RS (in its current iteration with Senate Floor Amendments) contains an appropriation of \$3 M for personnel costs associated with an additional sixty warrants for FY 27, or \$411,000 less than projected expenditures (including retirement and Medicare).
