**EXPENDITURE EXPLANATION**

Proposed law is permissive in nature and authorizes each postsecondary system management board to make student identification cards within its system available as a digitized credential through LA Wallet. To the extent a system management board elects to do so, integration cost may be significant, approximately \$50,000 to \$100,000 per enrollment database, plus ongoing maintenance costs.

According to the LA Wallet vendor, integration that includes only the student's name and a unique identifier would cost approximately \$50,000 to \$100,000 per enrollment database accessed. The LSU System maintains eight databases (one per campus), resulting in an estimated cost of \$400,000 to \$800,000. LCTCS and the Southern System maintain one systemwide database each, resulting in an estimated cost of \$100,000 to \$200,000. The LFO has requested additional information from the University of Louisiana System regarding the number of enrollment databases it maintains. If a system operates a single systemwide database, the cost would be \$50,000 to \$100,000; if not, the cost would be \$50,000 to \$100,000 per campus. This fiscal note will be updated once the additional information is received.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
