HOUSE BILL NO. 155

BY REPRESENTATIVE HARDY AND SENATORS APPEL, CROWE, DORSEY, GUILLORY, MOUNT, AND MARIONNEAUX

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1	AN ACT
2	To amend and reenact R.S. 14:32(A) and 39 and to enact R.S. 14:32(C)(3), (D), and (E), and
3	R.S. 22:1320, relative to certain crimes involving criminal negligence; to amend the
4	definition of negligent homicide to include the killing of a human being by a dog or
5	other animal; to amend the definition of negligent criminal injuring to include an
6	injury caused by a dog or other animal; to provide for exceptions; to provide for
7	definitions; to prohibit the denial of insurance coverage for certain cases of criminal
8	negligence; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. The ownership of dangerous dogs has become an increasing problem in
11	Louisiana resulting in the injury or death of many people following an encounter with a
12	dangerous dog. The Louisiana Legislature hereby finds that owners of dangerous dogs who
13	fail to properly confine or restrain them should be criminally responsible for the injuries
14	their animals cause to the citizens of this state. This Act shall be known as the "Luna
15	McDaniel and Michael 'Blaise' Landry Act" in honor of Mrs. Luna McDaniel, a resident of
16	Ville Platte, Louisiana, and Michael "Blaise" Landry, a resident of Morganza, who were both
17	attacked by dogs and died as a result of their injuries sustained during those attacks.
18	Section 2. R.S. 14:32(A) and 39 are hereby amended and reenacted and R.S.
19	14:32(C)(3), (D), and (E), and R.S. 22:1320 are hereby enacted to read as follows:
20	§32. Negligent homicide
21	A. Negligent homicide is <u>either of the following</u> :
22	(1) the The killing of a human being by criminal negligence.

2	is reckless and criminally negligent in confining or restraining the dog or other
3	animal.

7	(3) If the victim was killed by a dog or other animal, the owner of the dog
8	or other animal shall be imprisoned with or without hard labor for not more than five
9	years or fined not more than five thousand dollars, or both.
10	D. The provisions of this Section shall not apply to:
11	(1) Any dog which is owned, or the service of which is employed, by any
12	state or local law enforcement agency for the principal purpose of aiding in the
13	detection of criminal activity, enforcement of laws, or apprehension of offenders.
14	(2) Any dog trained in accordance with the standards of a national or
15	regional search and rescue association to respond to instructions from its handler in
16	the search and rescue of lost or missing individuals and which dog, together with its
17	handler, is prepared to render search and rescue services at the request of law
18	enforcement.
19	(3) Any guide or service dog trained at a qualified dog guide or service
20	school who is accompanying any blind person, visually handicapped person, deaf
21	person, hearing impaired person, or otherwise physically disabled person who is
22	using the dog as a guide or for service.
23	(4) Any attack made by a dog lawfully inside a dwelling, a place of business,
24	or a motor vehicle as defined in R.S. 32:1(40), against a person who is attempting to
25	make an unlawful entry into the dwelling, place of business, or motor vehicle, or
26	who has made an unlawful entry into the dwelling, place of business, or motor
27	vehicle, and the dog is protecting that property.
28	(5) Any attack made by livestock as defined in this Section.

1	E. For the purposes of this Section:
2	(1) "Harboring or keeping" means feeding, sheltering, or having custody
3	over the animal for three or more consecutive days.
4	(2) "Livestock" means any animal except dogs and cats, bred, kept,
5	maintained, raised, or used for profit, that is used in agriculture, aquaculture,
6	agritourism, competition, recreation, or silvaculture, or for other related purposes or
7	used in the production of crops, animals, or plant or animal products for market.
8	This definition includes but is not limited to cattle, buffalo, bison, oxen, and other
9	bovine; horses, mules, donkeys, and other equine; goats; sheep; swine; chickens,
10	turkeys, and other poultry; domestic rabbits; imported exotic deer and antelope, elk,

13	located in artificial reservoirs or enclosures that are both on privately owned property

16	mixture, or mutation of any such animal.

18	owning, harboring, or keeping any animal.

20	§39. Negligent injuring
21	<u>A.</u> Negligent injuring is <u>either of the following:</u>
22	(1) the The inflicting of any injury upon the person of another by criminal
23	negligence.
24	(2) The inflicting of any injury upon the person of another by a dog or other
25	animal when the owner of the dog or other animal is reckless and criminally
26	negligent in confining or restraining the dog or other animal.
27	\underline{B} . The violation of a statute or ordinance shall be considered only as
28	presumptive evidence of such negligence.
29	\underline{C} . Whoever commits the crime of negligent injuring shall be fined not more
30	than five hundred dollars, or imprisoned for not more than six months, or both.

9	<u>§1320.</u> Prohibition of denial of coverage
10	Notwithstanding anything to the contrary, liability coverage, which would
11	otherwise be valid under the terms of the policy, shall not be declared void under any
12	contract provision which specifically denies coverage for any and all acts committed
13	due to criminal conduct, where such criminal conduct is due to the criminally
14	negligent ownership or handling of a dog or other animal pursuant to R.S.
15	<u>14:32(A)(2) or R.S. 14: 39(A)(2).</u>
