ELECTIONS: Provides for an open primary system of elections for congressional offices

1 AN ACT

2 To amend and reenact R.S. 18:44(A) and (B)(5)(b), 110(B), 193(F), 197, 401(B), 402(B),
3 (C)(introductory paragraph), (E), and (G), 433(G)(1) and (H)(1)(introductory
4 paragraph), 434(A)(1), (C)(introductory paragraph), and (D)(1) and (2), 435(A)(1)
5 and (B), 436, 453(A) and (B), 467(introductory paragraph) and (2), 468(A), 481,
6 491(A) and (C), 511(A) and (B), 512(B), 535(B), 552(A)(introductory paragraph),
7 1272(A), 1278(B), 1279, 1285(B)(1)(a), 1300(C)(1), 1300.7(A), 1306(A)(4) and
8 (C)(2), 1307(A)(8) and (E), 1308(A)(2)(a), 1314(B) and (C), 1355(6), 1401(B),

10 1461(A)(17) and to repeal R.S. 18:1275.1 through 1275.24, relative to elections; to
11 provide for an open primary system of elections for congressional offices; to provide
12 relative to objections to candidacy and contests of elections; to provide relative to
13 changes to and challenge and cancellation of voter registration; to provide relative
14 to procedures for voting; to provide for election dates; to provide relative to courses
15 of instruction for commissioners; to provide relative to selection and replacement of
16 commissioners; to provide relative to alternate commissioners; to provide relative
17 to watchers; to provide relative to dual candidacy; to provide relative to qualification
18 of candidates; to provide relative to the election of candidates in a primary and
19 general election; to provide relative to notice of location of precincts and polling
20 places; to provide relative to election materials; to provide relative to filling

1 vacancies in federal offices; to provide relative to recall elections; to provide relative
2 to absentee by mail and early voting; to provide relative to voting machines; to
3 provide relative to election offenses; and to provide for related matters.

4 Be it enacted by the Legislature of Louisiana:

5 Section 1. R.S. 18:44(A) and (B)(5)(b), 110(B), 193(F), 197, 401(B), 402(B),
6 (C)(introductory paragraph), (E), and (G), 433(G)(1) and (H)(1)(introductory paragraph),
7 434(A)(1), (C)(introductory paragraph), and (D)(1) and (2), 435(A)(1) and (B), 436, 453(A)
8 and (B), 467(introductory paragraph) and (2), 468(A), 481, 491(A) and (C), 511(A) and (B),
9 512(B), 535(B), 552(A)(introductory paragraph), 1272(A), 1278(B), 1279, 1285(B)(1)(a),
10 1300(C)(1), 1300.7(A), 1306(A)(4) and (C)(2), 1307(A)(8) and (E), 1308(A)(2)(a), 1314(B)
11 and (C), 1355(6), 1401(B), 1402(B)(1)(c), 1405(A), 1406(B), 1407, 1409(B)(1) and (2),
12 1432(A), and 1461(A)(17) are hereby amended and reenacted to read as follows:

13 §44. Contesting election; referral for prosecution

14 A. Whenever the board determines as a result of an investigation that
15 violations of law, irregularities, error, or fraud have occurred in the conduct of an
16 election which in the judgment of the board has resulted in the apparent qualification
17 for the ~~second party primary election or for the~~ general election or the apparent
18 election of a candidate not entitled to be so qualified or elected, the board, upon the
19 favorable vote of three members, may institute suit to contest the election in order
20 to protect the interest and rights of the state in fair and honest elections. In addition,
21 for the same cause and upon the same vote, the board may intervene in any suit
22 instituted by any other party to contest an election.

23 B. In any suit instituted by the board to contest an election, the provisions
24 of Chapter 9 of this Title shall apply, except that:

26 (5) The petition shall contain, but shall not be limited to, the following:

27 * * *

28 (b) The allegation that except for substantial irregularities or error, fraud, or
29 other unlawful activities in the conduct of the election, a different candidate would

1 have qualified for a ~~second party primary election or a~~ general election or would
2 have been elected.

4 §110. Removal from precinct; removal from parish

5 * * *

6 B.(1) A change of registration based upon a change of residence within a
7 parish received after the closing of registration for a primary election shall become
8 effective the day after the general election or special general election when a special
9 primary election is held in conjunction with a general election except as follows:

10 (a) A person whose registration has been canceled pursuant to R.S.
11 18:193(G).

12 (b) A person whose registration has been canceled or whose address has been
13 corrected pursuant to R.S. 18:196(C).

14 ~~(2) A change of registration based upon a change of residence within a parish~~
15 ~~received after the closing of registration for a first party primary election or special~~
16 ~~first party primary election and prior to the closing of registration for the second~~
17 ~~party primary election or special second party primary election shall become~~
18 ~~effective prior to the second party primary election or special second party primary~~
19 ~~election, except as follows:~~

20 ~~(a) A person whose registration has been canceled pursuant to R.S.~~

22 ~~(b) A person whose registration has been canceled pursuant to R.S.~~

24 ~~(3)~~ (2) The change of residence of a registrant from one precinct to another
25 in the same parish does not deprive him of the right to remain as a legal registrant,
26 as to all issues upon which he was entitled to vote prior to his change of residence,
27 in the precinct from which he has removed until he changes his registration as

1 provided in Subsection A of this Section and has the right to vote in the precinct to
2 which he has moved.

3 ~~(4)~~ (3) However, in a regularly scheduled general election where the only
4 candidate's election appearing on any ballot in the parish is a special primary
5 election, then in such instance, the change shall become effective prior to the special
6 primary election. In a regularly scheduled or special general election, where the
7 change of registration does not change any issues or candidate offices upon which
8 the voter was entitled to vote prior to the change, the change shall become effective
9 prior to the regularly scheduled or special general election.

11 §193. Challenge and cancellation of registration; notice; procedures

12 * * *

13 F. A list of names and addresses to whom address confirmation notices are
14 sent and whether or not each person responded to the confirmation notice shall be
15 maintained for a period of two years and shall be open to inspection and copying as
16 provided in R.S. 18:154. Ninety days prior to a regularly scheduled ~~first party~~
17 federal primary election, the names and addresses of those persons on the inactive
18 list shall be published for one day in the official journal of the parish governing
19 authority or in a newspaper calculated to provide maximum notice in the parish.

21 §197. Registration; cancellation

22 No registrar of voters shall cancel the registration of any voter in his parish
23 between any primary ~~or first party primary~~ election, ~~as the case may be~~, and the
24 subsequent general election occurring in that parish as a result of any of the
25 processes authorized by this Part, except in the case of a person who has been
26 fraudulently placed upon the registration records or in the case of a person whose
27 registration is canceled pursuant to the annual canvass conducted by the registrar.

1 §401. Purpose and nature of primary and general elections

2 * * *

3 B. Nature. ~~(1) Except for the election of persons to congress, all~~ All
4 qualified voters of this state may vote on candidates for public office in primary and
5 general elections without regard to the voter's party affiliation or lack of it, and all
6 candidates for public office who qualify for a primary or general election may be
7 voted on without regard to the candidate's party affiliation or lack of it.

8 ~~(2)(a) In the election of persons to congress, the following shall apply:~~

9 ~~(i) In primary elections, recognized political parties shall make all~~
10 ~~nominations of candidates by direct primary elections held under the provisions of~~
11 ~~this Chapter. In primary elections, each qualified voter may vote only on the~~
12 ~~candidates for public office who are affiliated with the same political party with~~
13 ~~which the voter is affiliated. In primary elections, each qualified voter who is not~~
14 ~~affiliated with a recognized political party may choose to vote in one recognized~~
15 ~~political party's primary elections, except as otherwise provided by R.S. 18:1275.1.~~

16 ~~(ii) In general elections, each qualified voter of this state may vote for~~
17 ~~candidates for public office in general elections without regard to the voter's party~~
18 ~~affiliation or lack thereof, and all candidates for public office who qualify for a~~
19 ~~general election may be voted for without regard to the candidates' party affiliation~~
20 ~~or lack thereof.~~

23 * * *

24 B. Congressional elections. Elections for members of ~~Congress~~ congress and
25 officers elected at the same time as members of ~~Congress~~ congress shall be held
26 every two years, beginning in 1982.

27 (1) ~~Congressional first primary elections for recognized political parties shall~~
28 ~~be held on the first Saturday in September of an election year.~~

1 ~~(2) Congressional second primary~~ Primary elections for ~~recognized political~~
2 ~~parties and primary elections for~~ members of congress and officers elected at the
3 same time as members of ~~Congress~~ congress shall be held on the first ~~Saturday in~~
4 ~~October~~ Tuesday after the first Monday in November of an election year.

5 ~~(3) Congressional general~~ (2) General elections for members of congress and
6 officers elected at the same time as members of congress shall be held on the first
7 ~~Tuesday after the first Monday in November of an election year~~ Saturday in
8 December of an election year.

9 C. Municipal and ward elections. In all municipalities with a population of
10 less than four hundred seventy-five thousand, elections for municipal and ward
11 officers who are not elected at the same time as the governor or members of congress
12 shall be held every four years. ~~The primary election for municipal and ward officers~~
13 ~~who are elected at the same time as members of Congress shall be held on the same~~
14 ~~date as the congressional second party primary, and the general election shall be held~~
15 ~~at the same time as the general election for congressional offices.~~

17 E. Special elections to fill newly created office or vacancy in office. An
18 election to fill a newly created office or vacancy in an existing office, except the
19 office of state legislator or representative in congress, shall be held on the dates fixed
20 by the appropriate authority in the proclamation ordering a special election as
21 follows:

22 (1) A special primary election shall be held on the first of the following days
23 that is not less than eleven weeks after the date on which the proclamation calling the
24 special primary election was issued:

25 (a) The second to last Saturday in October, when the special general election
26 is held on the fourth Saturday after the second to last Saturday in October.

27 (b) The first Tuesday after the first Monday in November, when the special
28 general election is held on the first Saturday in December.

1 ~~(b)~~(c) The first Saturday in April, when the special general election is held
2 on the fourth Saturday after the first Saturday in April or on the second or third
3 Saturday in February during the presidential election year, if the statewide
4 presidential preference primary election is scheduled on the second or third Saturday
5 in February of the presidential election year; however, commencing in 1986 and
6 every fourth year thereafter, this date shall not be applicable in a parish containing
7 a municipality with a population of four hundred seventy-five thousand or more.

8 ~~(c)~~(d) The third Saturday in October, when the special general election is
9 held on the fourth Saturday after the third Saturday in October of 1985 and every
10 fourth year thereafter.

11 ~~(d)~~(e)(i) The first Saturday in February of an election year for parish and
12 municipal officers in a parish containing a municipality with a population of four
13 hundred seventy-five thousand or more.

14 (ii) The first Saturday in February of 1995, except in parishes and
15 municipalities where an election on bonds, taxes, and other propositions or questions
16 has been called and held in January of 1995. Notwithstanding the provisions
17 contained in R.S. 18:467 and 468, the qualifying period for primary elections held
18 on the first Saturday in February of 1995 shall open on the third Monday in
19 December of 1994 and shall close at 5:00 p.m. on the Wednesday following the third
20 Monday in December of 1994.

21 ~~(2) A special primary election shall be held on the first of the following days
22 which is not less than fifteen weeks after the date on which the proclamation calling
23 the special primary election was issued: the first Saturday in October, when the
24 special general election is held on the first Tuesday after the first Monday in
25 November.~~

26 ~~(3)~~(2) A special general election shall be held on one of the following days:

27 (a) The fourth Saturday after the second to last Saturday in October of 1983
28 and every fourth year thereafter.

1 (b) The first ~~Tuesday after the first Monday in November~~ Saturday in
2 December of even-numbered years.

3 (c) The fourth Saturday after the first Saturday in April of any year unless
4 the primary election is held on the second or third Saturday in February; in such case
5 the general election shall be held on the fourth Saturday after the second or third
6 Saturday in February, as the case may be; however commencing in 1986 and every
7 fourth year thereafter, this date shall not be applicable in a parish containing a
8 municipality with a population of four hundred seventy-five thousand or more.

9 (d) The fourth Saturday after the third Saturday in October of 1985 and every
10 fourth year thereafter.

11 (e)(i) The fourth Saturday after the first Saturday in February in a parish
12 containing a municipality with a population of four hundred seventy-five thousand
13 or more, when the special primary election in such parish and municipality is held
14 on the first Saturday in February of an election year for parish and municipal
15 officers.

16 (ii) The fourth Saturday after the first Saturday in February of 1995, when
17 the special primary election is held as authorized in ~~R.S. 18:402(E)(1)(e)(ii)~~ Item
18 (1)(e)(ii) of this Subsection on the first Saturday in February of 1995.

19 ~~(4)~~ (3) The secretary of state shall not include the name of any candidate on
20 any ballot for a special election to fill a vacancy in any office to which this
21 Subsection is applicable unless such special election has been called in accordance
22 with the provisions of this Subsection and scheduled on one of the dates provided
23 herein. Any elector who is eligible to vote in any such special election may apply
24 for injunctive relief to prohibit the placing of the name of any candidate in an
25 improperly called election on the ballot. Venue for such application shall be in any
26 parish in which the election is called, and the secretary of state shall be the proper
27 party defendant.

1 G. Prohibited days. No election of any kind shall be held in this state on any
 2 of the days of Rosh Hashanah Hashana, Yom Kippur, ~~Sukkoth~~ Sukkot, ~~Shimini~~
 3 ~~Atzereth~~ Shemini Atzeret, ~~Simchas Torah~~ Simchat Torah, the first two days and the
 4 last two days of Passover, ~~Shavuoth~~ Shavuot, ~~Fast of AV~~ Tish'a B'Av, the two days
 5 preceding Labor Day or the three days preceding Easter. If the date of any election
 6 falls on any of the ~~above named~~ above-named days, the election shall be held on the
 7 same weekday of the preceding week. ~~If the date of the election for a second party~~
 8 ~~primary is advanced pursuant to this Subsection, the first party primary shall also be~~
 9 ~~advanced by the same number of weeks.~~

11 §433. Commissioners-in-charge; course of instruction; selection; commission;
 12 disqualification; replacement

13 * * *

14 G. Replacement. (1) Except as provided in Subsection H of this Section, if
 15 it becomes certain that a commissioner-in-charge will not be able to serve for a
 16 primary ~~or first party primary~~ election, or if a commissioner-in-charge fails to attend
 17 a course of instruction held immediately prior to a primary ~~or first party primary~~
 18 election as provided in R.S. 18:431(B), the parish board of election supervisors shall
 19 select a replacement commissioner-in-charge who shall serve for both the primary
 20 ~~or first party primary~~ and general elections. Except as provided in Subsection H of
 21 this Section, if it becomes certain that a commissioner-in-charge will not be able to
 22 serve for a ~~second party primary or a~~ general election, or if a commissioner-in-
 23 charge fails to attend the course of instruction held prior to a ~~second party primary~~
 24 ~~or a~~ general election, the parish board of election supervisors shall select a
 25 replacement commissioner-in-charge who shall serve for ~~both the second party~~
 26 ~~primary and~~ the general election.

28 H. Replacement. (1) If a commissioner-in-charge fails to appear at the
 29 polling place at least thirty minutes before the time when the polls are to open on

1 election day, the commissioners in attendance at the polling place shall immediately
 2 notify the clerk of court of the absence. Immediately upon receipt of the notice, the
 3 clerk of court shall select a replacement commissioner-in-charge for that precinct.
 4 Subject to the provisions of Subsection G of this Section, a replacement
 5 commissioner-in-charge selected for a primary ~~or first party primary~~ election also
 6 shall serve for the ~~second party primary and the~~ general election. The replacement
 7 commissioner-in-charge shall be selected from the following categories in the order
 8 of priority listed:

10 §434. Commissioners and alternate commissioners; selection; commission;
 11 disqualification; replacement

12 A. Time and place of selection. (1) The parish board of election supervisors
 13 shall meet at 10:00 a.m. on the twenty-ninth day before a primary ~~or first party~~
 14 primary election to select the commissioners and alternate commissioners for each
 15 precinct. The meeting shall be open to the public. The board shall have previously
 16 posted a notice on the front courthouse door designating the location within the
 17 courthouse where the meeting is to be held.

19 C. Commission. Once the commissioners and alternate commissioners are
 20 selected for a primary, ~~first party primary, second party primary,~~ and general
 21 election, the parish board of election supervisors shall immediately:

23 D. Replacement of a commissioner. (1) If prior to the day of the election
 24 a commissioner notifies the parish board of election supervisors that he is unable to
 25 serve as commissioner, the parish board of election supervisors shall select an
 26 alternate commissioner to serve in place of the absent commissioner. An alternate
 27 commissioner who replaces an absent commissioner in a ~~primary or first party~~
 28 primary election shall replace the absent commissioner in the ~~second party primary~~
 29 ~~and in the~~ general election. ~~An alternate commissioner who replaces an absent~~

1 ~~commissioner in a second party primary election shall replace the absent~~
2 ~~commissioner in the general election.~~ If there are no alternate commissioners or an
3 insufficient number of alternate commissioners available, the parish board of election
4 supervisors shall select a person to serve as commissioner from the list containing
5 the names of persons within that ward who have received certificates of instruction
6 from the clerk of court pursuant to R.S. 18:431(A)(1). If no person on that list is
7 available to serve as commissioner, the parish board of election supervisors shall
8 select any person within the parish who has received a certificate of instruction from
9 the clerk of court pursuant to R.S. 18:431(A)(1). If there is no such qualified person
10 available, the parish board of election supervisors shall select a watcher.

11 (2) If a commissioner fails to appear at the polling place at least thirty
12 minutes before the time when the polls are to open on election day, or if a
13 commissioner is selected as commissioner-in-charge, the commissioner-in-charge
14 shall select an alternate commissioner to serve in place of the absent commissioner.
15 An alternate commissioner who replaces an absent commissioner in a ~~primary or~~
16 ~~first party~~ primary election shall replace the absent commissioner in the ~~second party~~
17 ~~primary and in the~~ general election. ~~An alternate commissioner who replaces an~~
18 ~~absent commissioner in a second party primary election shall replace the absent~~
19 ~~commissioner in the general election.~~ If there are no alternate commissioners or an
20 insufficient number of alternate commissioners available, the commissioner-in-
21 charge shall select a person to serve as commissioner from the list containing the
22 names of those who have received certificates of instruction that was furnished him
23 by the parish board of election supervisors pursuant to R.S. 18:431(A)(5). If no
24 person on that list is available to serve as commissioner, the commissioner-in-charge
25 shall select any person present at the polls who possesses the qualifications of a
26 commissioner as set forth in R.S. 18:425(B). If there is no such qualified person
27 available, the commissioner-in-charge shall select a watcher.

1 §435. Watchers; appointment and commission

2 A. Right to have watchers. (1) Each candidate is entitled to have one
3 watcher at every precinct where the office he seeks is voted on in ~~any~~ a primary or
4 general election. The candidate or his authorized representative shall file one list of
5 watchers on a form provided by the secretary of state or on a form which contains
6 the same information as required by the form provided by the secretary of state.
7 When a candidate's list of watchers is filed by the candidate's authorized
8 representative, a letter of authorization from the candidate shall accompany the list
9 of watchers; ~~However~~ however, in the case of a presidential election, each slate of
10 candidates for presidential elector is entitled to have one watcher at every precinct.
11 The state central committee of each recognized political party shall be responsible
12 for filing the list of watchers for its slate of candidates for presidential elector. The
13 list of watchers for an independent or other party slate of candidates for presidential
14 elector shall be filed by any person so authorized by the presidential candidate
15 supported by the slate of electors. A letter of authorization from the presidential
16 candidate, or an authorized agent of his campaign, shall accompany the list of
17 watchers.

19 B. Lists of watchers. A list of watchers shall be filed with the clerk of court
20 before 5:00 p.m. on the tenth day before ~~any~~ the primary or general election;
21 ~~However~~ however, if the tenth day before ~~any~~ the primary or general election falls
22 on a Saturday, Sunday, or other legal holiday, the list shall be filed on the next day
23 which is not a Saturday, Sunday, or other legal holiday. Except for a candidate or
24 recognized political party filing for a slate of candidates for presidential elector, any
25 person filing a list of watchers must attach a certified statement that the report
26 required by R.S. 18:1486 has been filed with the supervisory committee in
27 compliance with the Campaign Finance Disclosure Act. If any candidate submits a
28 list for the ~~primary or first party~~ primary election and does not submit a list for the
29 ~~second party primary or the~~ general election, the list submitted in the ~~primary or first~~

1 party primary election shall be treated as his list submitted for the ~~second party~~
2 ~~primary election and the~~ general election. ~~If any candidate submits a list for the~~
3 ~~second party primary election and does not submit a list for the general election, the~~
4 ~~list submitted in the second party primary election shall be treated as his list~~
5 ~~submitted for the general election.~~ A list of watchers shall contain only one watcher
6 and one alternate watcher for each precinct where the candidate or person submitting
7 the list is entitled to have a watcher. The list shall be typed or legibly written, and
8 it shall contain the name and mailing address of each watcher and a designation of
9 the precinct where he is to serve.

§436. Election officials at certain special elections

A. When a special primary election to fill a vacancy or an anticipated
vacancy in elective public office is called to be held at the same time as a previously
scheduled general election, or if a previously scheduled election is delayed for any
reason, the commissioners who were selected to serve at the previously scheduled
~~primary or first party and second party primary~~ and general election also shall be the
commissioners for the special primary and general elections and any such delayed
~~primary or general election~~, and the compensation for each shall be only that amount
provided for in R.S. 18:426.1 for a day of service as a commissioner or
commissioner-in-charge. Each candidate to be voted on in the special primary
election or delayed primary election may appoint one watcher for each precinct in
which that candidate is to be voted on. Notwithstanding the provisions of R.S.
18:427(C) or of any other law to the contrary, the watchers so appointed shall be
allowed to remain in the polling place at all times.

B. When a special general election to fill a vacancy or an anticipated
vacancy in elective public office is called to be held at the same time as a previously
scheduled primary election, the commissioners who were selected to serve at the
special primary election for which the special general election is to be held shall also
be the commissioners for both the previously scheduled primary, ~~and including any~~

1 ~~first party or second party primary~~ and general elections. In such case the
2 compensation for each shall be only that amount provided for in R.S. 18:426.1 for
3 a day of service as a commissioner or commissioner-in-charge.

5 §453. Dual candidacy

6 A. General prohibitions. A person shall not become a candidate in any a
7 ~~primary, first party or second party primary~~ or general election for more than one
8 office unless one of the offices is membership on a political party committee, nor
9 shall a person be a candidate at the same time for two or more different offices to be
10 filled at separate elections.

11 B. Unexpired and succeeding term of office. A person may become a
12 candidate in a primary ~~or first or second party primary election~~ or general election
13 for the unexpired and the succeeding term of an office when both terms are to be
14 filled at the same election.

16 §467. Opening of qualifying period

17 The qualifying period for candidates in ~~the first party primary~~ or a primary
18 election shall open:

19 * * *

20 (2) For candidates in a ~~primary~~ or congressional ~~first party~~ primary election
21 and those in any special primary ~~or first party primary~~ election to be held at the same
22 time, on the ~~second~~ third Wednesday in ~~July~~ August of the year of the election.

24 §468. Close of the qualifying period

25 A. The qualifying period for candidates in a primary ~~or first party primary~~
26 election shall close at 5:00 p.m. on the Friday after the opening of the qualifying
27 period for candidates in the primary ~~or first party primary~~ election or, if that Friday
28 is a legal holiday, at 5:00 p.m. on the next day which is not a legal holiday.

1 §481. Candidates who qualify for a general election

2 ~~Except for candidates for the public office of United States senator or~~
3 ~~representative in Congress, The~~ candidates who qualify for each office remaining to
4 be filled in the general election are those who received the two highest numbers of
5 votes, the four highest number of votes, and so on among those not elected in the
6 primary election, until the maximum number of candidates for each office on the
7 general election ballot is reached.

9 §491. Standing to object to candidacy

10 A. A registered voter may bring an action objecting to the candidacy of a
11 person who qualified as a candidate in a ~~primary or first party~~ primary election for
12 an office for which the plaintiff is qualified to vote.

Abstract: Provides for an open primary system of elections for congressional offices.

Present law provides for a closed primary system for the election of members of congress, which includes first party primary, second party primary, and general elections.

Present law provides that all recognized political parties shall make nominations of all congressional candidates by direct party primary elections. Provides that in such party primary elections, all qualified voters of the state may vote on the candidates for public office who are affiliated with the same political party with which the voter is affiliated;

however, present law allows voters unaffiliated with a recognized political party to vote in a party primary election of a party which chooses to allow such voters to vote by party rules and regulations, but permits such a voter to cast a vote in only one such primary related to each election.

Present law provides that a candidate in a congressional first primary election must be affiliated with a recognized political party and may qualify as a candidate only in the party primary of the party with which he is affiliated as shown in his voter registration.

Present law provides that if after the close of qualifying, the number of persons to be nominated by a recognized political party for a congressional office does not exceed the number of persons to be nominated by that party, those persons are declared nominated and their names shall appear on the general election ballot, but not on the ballot in the second primary.

Present law provides that a majority vote is required in the congressional first party primary election for a candidate to be nominated by his party as a congressional candidate in the general election to the office he seeks. Further provides that absent such majority vote the two candidates from the same party receiving the highest number of votes in the first party primary shall be voted on in the second party primary.

Present law provides relative to tie votes in the first party primary and death, withdrawal, and disqualification of a candidate. Provides further that there shall be no third party primary and further that the state central committee shall provide for the selection of a nominee of their party in any situation not specifically provided for by statute.

Present law provides that the congressional candidate from each political party who received the highest number of votes in the second party primary shall qualify for the general election as well as any candidate who received a majority in the first party primary. Provides that the number of candidates that may qualify for the general election by party nomination is one candidate from each recognized political party.

Present law provides that a person who is not affiliated with a recognized political party may become a candidate in a general election by filing his notice of candidacy, which shall be accompanied by either the qualifying fee or a ballot access petition with the same number of signatures required for candidates in the first party primary, in the same manner and during the same time period as is provided for candidates in the first party primary who are affiliated with a recognized political party.

Present law provides that all qualified voters may vote on candidates for public office in general elections without regard to the voter's party affiliation or lack thereof, and all candidates for public office who qualify for a general election may be voted on without regard to the candidate's party affiliation or lack thereof. Present law specifies that in a general election, the candidate with the most votes is elected whether or not he receives a majority of the total votes cast.

Present law provides that congressional first party primary elections be held on the first Saturday in Sept. and congressional second party primary elections and primary elections for officers elected at the same time as members of congress on the first Saturday in Oct. in even-numbered years.

Present law provides that the general election date for members of congress and officers elected at the same time as members of congress is the first Tuesday after the first Monday in Nov.

Proposed law repeals present law. Provides that all qualified voters of this state may vote on candidates for public office in both primary and general elections, including congressional elections, without regard to the voter's party affiliation or lack thereof, and that

all candidates for public office who qualify for a primary or general election may be voted on without regard to the candidate's party affiliation or lack thereof.

Proposed law provides that all candidates, including congressional candidates, run in a single primary, and that, unless a candidate receives a majority vote in the primary and is elected, the top two candidates are the candidates in the general election.

Proposed law provides that a candidate, including a congressional candidate, who receives a majority of the votes cast for an office in a primary election is elected.

Proposed law provides that the candidate who receives the most votes cast for an office in a general election is elected.

Proposed law provides that primary elections for members of congress and for officers elected at the same time as members of congress shall be held on the first Tuesday after the first Monday in Nov. of an election year. Provides that general elections for members of congress and for officers elected at the same time as members of congress shall be held on the first Saturday in Dec. of an election year.

Proposed law establishes procedures for carrying out the provisions of the election system established by proposed law.

Proposed law deletes all provisions relative to a closed primary system for congressional candidates, and deletes from present law all references and provisions applicable to the closed primary system for congressional elections contained in present law, including references to first party primary and second party primary.

Proposed law otherwise retains present law.
