HOUSE CONCURRENT RESOLUTION NO. 25

STUDENT/ASSESSMENT: Requests that the State Board of Elementary and Secondary Education study issues related to the assessment of foreign exchange students

1	A CONCURRENT RESOLUTION
2	To urge and request the State Board of Elementary and Secondary Education to study issues
3	related to the assessment of foreign exchange students and to submit a written report
4	of its findings and conclusions, including any recommendations for legislation
5	relative to the issue, to the House Committee on Education and the Senate
6	Committee on Education not later than sixty days prior to the beginning of the 2012
7	Regular Session of the Legislature of Louisiana.
8	WHEREAS, as stated in the Constitution of Louisiana, it is the goal of the public
9	educational system to provide learning environments and experiences at all stages of human
10	development that are humane, just, and designed to promote excellence in order that every
11	individual may be afforded an equal opportunity to develop to his full potential; and
12	WHEREAS, according to the State Board of Elementary and Secondary Education
13	(BESE) rule, Title 28, Part CXI, Section 3505, foreign exchange students shall take the
14	appropriate assessment for their enrolled grade during the scheduled assessment period; and
15	WHEREAS, since foreign exchange students are expected to be fully proficient in
16	English, they are not eligible for test accommodations; and
17	WHEREAS, though foreign exchange students are expected to be fully proficient in
18	English, there is concern that some are not and that this can be detrimental to both the
19	students' learning experiences and School Performance Scores used in the state's school and
20	district accountability program; and

WHEREAS, BESE rule, Part CXI, Section 3307, provides for certain approved
accommodations in the testing of Limited English Proficient (LEP) students, including
extended time/adjusted time, individual/small group instruction, provision of English/native
language word-to-word dictionary, the test being read aloud, and the test being administered
by an English as a Second Language (ESL) teacher or by the individual providing language
services; and

WHEREAS, foreign language students' educational experiences, as well as the
chances of both the students and their schools being successful in the area of assessment,
might improve if certain test accommodations, perhaps similar to those provided for LEP
students, were provided for foreign exchange students; and

WHEREAS, in order to fulfill the state's constitutional duty of affording every student an equal opportunity to develop to his full potential, it is imperative that issues related to the assessment of foreign exchange students receive a thorough evaluation.

14 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 15 urge and request the State Board of Elementary and Secondary Education to study issues 16 related to the assessment of foreign exchange students and to submit, in compliance with 17 R.S. 24:771 and 772, a written report of its findings and conclusions, including any 18 recommendations for legislation relative to the issue, to the House Committee on Education 19 and the Senate Committee on Education not later than sixty days prior to the beginning of 20 the 2012 Regular Session of the Legislature.

BE IT FURTHER RESOLVED that such issues shall include but not be limited to an examination of the English proficiency levels of foreign exchange students, the effect of the assessment of such students on School Performance Scores, and the possibility of allowing certain test accommodations in the assessment of such students.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
 president of the State Board of Elementary and Secondary Education.
