WATER QUALITY. Provides for the membership, powers, and duties of the Ground Water Management Advisory Task Force. (8/15/11)

1	AN ACT
2	To enact R.S. 36:359(L) and R.S. 38:3097.7 and to repeal Section 4 of Act No. 446 of the
3	2001 Regular Session of the Legislature and Section 5 of Act No. 49 of the 2003
4	Regular Session of the Legislature, relative to the Ground Water Management
5	Advisory Task Force; to provide for the membership of the task force; to provide
6	powers, duties, terms and conditions; to provide for the meeting requirements of the
7	task force; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 36:359(L) is hereby enacted to read as follows:
10	§359. Transfer of agencies and functions to Department of Natural Resources
11	* * *
12	L. The Ground Water Management Advisory Task Force shall be
13	placed within the office of conservation, Department of Natural Resources, and
14	shall perform its powers, duties, functions, and responsibilities in the manner
15	provided by law.
16	Section 2. R.S. 38:3097.7 is hereby enacted to read as follows:
17	<u>§3097.7. Ground Water Management Advisory Task Force</u>

1	A. A comprehensive ground water management program must continue
2	to be developed and implemented. To that end, there is hereby created a
3	Ground Water Management Advisory Task Force with membership as follows:

7	(3) The speaker of the Louisiana House of Representatives or his

21	<b>B. The Ground Water Management Advisory Task Force shall assist the</b>
22	commissioner of conservation and the Ground Water Resource Commission in
23	continuing to develop a statewide ground water resource management program.
24	Such ground water management program shall include but not be limited to
25	evaluation of the state's ground water resources including current and
26	projected demands on the aquifers of the state; development of a water use
27	conservation program; study of alternatives to ground water use, such as
28	surface water to include treatment and transmission system, and reclaimed
29	water; incentives for conservation; use of alternative technologies; and

1	education and conservation programs. The plan should stress conservation as
2	the primary mechanism for the protection of the state's ground water resources.
3	C.(1) Fifteen members of the task force shall constitute a quorum. A
4	quorum being present, the favorable vote of at least ten members of the task
5	force or a simple majority of the total membership present, whichever is
6	greater, shall be required for the commission to take action on any matter.
7	(2) The task force shall meet at least once per year, or more frequently
8	as necessary. The task force shall report to the commissioner and the
9	commission periodically on the activities and progress of the task force on
10	continuing to develop the comprehensive ground water management program.
11	Section 3. Section 4 of Act No. 446 of the 2001 Regular Session of the Legislature
12	and Section 5 of Act No. 49 of the 2003 Regular Session of the Legislature are hereby
13	repealed.

## DIGEST

Long (SB 48)

<u>Present law</u> provides for the membership of the Ground Water Management Advisory Task Force, for the powers and duties of the task force, and for the meeting requirements of the task force.

<u>Proposed law</u> changes the membership and meeting requirements of the task force.

<u>Proposed law</u> provides that 15 members of the task force will constitute a quorum. Further provides that a quorum being present, the favorable vote of at least 10 members of the task force or a simple majority of the total membership present, whichever is greater, will be required for the commission to take action on any matter.

Effective August 15, 2011.
