HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Guillory to Engrossed Senate Bill No. 91 by Senator Long

1 AMENDMENT NO. 1

2 On page 1, line 3, after "Parish" and before the semi-colon ";" insert "and St. Landry Parish"

3 AMENDMENT NO. 2

4 On page 2, after line 9, insert the following:

5 **"Section 3. The secretary of the Department of Health and Hospitals and**
6 **the commissioner of the division of administration, notwithstanding any other**
7 **provision of law to the contrary, is hereby authorized and empowered to**
8 **convey, transfer, assign, lease or deliver any interest, excluding mineral rights,**
9 **the state may have to all or any portion of the following described parcel of**
10 **property to the city of Eunice:**

11 **A certain tract or parcel of land; containing 11.1 acres, more or less, situated**
12 **in the southwest part of the Town of Eunice, St. Landry Parish, Louisiana,**
13 **being more particularly described as beginning at a point N 0 degrees 08' West,**
14 **50 feet and N 89 degrees, 14' East, 60 feet from the southwest corner of Lot 8 of**
15 **a map of subdivision made for Heirs of Eloi Guillory, dated August 24, 1958,**
16 **signed by Lindsay J. Aucoin, Civil Engineer, thence from said point of**
17 **beginning N 0 degrees 8' West 798 feet, thence N 0 degrees 27.' West, 489.17 feet**
18 **to Ash Avenue, thence N 89 degrees 14' East, 329.8 feet, thence south along a**
19 **projection of the East line of Jake Avenue, 757.78 feet, thence East parallel to**
20 **the south line of Block 12 of the Suzanne Guillory Addition "B", 460 feet,**
21 **thence southwesterly 960 feet, more or less to point of beginning; and being**
22 **bounded as follows: North by Ash Avenue and St. Anthony Catholic Church,**
23 **southwest by City of Eunice Right of Way adjacent to drainage canal, East by**
24 **St. Anthony Catholic Church, and West by East line of John Street and/or the**
25 **East Right of Way of Transcontinental Gas Pipeline Corp., being that property**
26 **which DONOR acquired from The Society of the Roman Catholic Church of the**
27 **Diocese of Lafayette, Louisiana by Act of Donation dated April 9th, 1970 which**
28 **is duly recorded as original Act No. 547776 in the records of the Clerk of Court**
29 **of St. Landry Parish, Louisiana.**

30 **Section 4. The secretary of the Department of Health and Hospitals and**
31 **the commissioner of the division of administration are hereby authorized to**
32 **enter into such agreements, covenants, conditions, and stipulations and to**
33 **execute such documents as necessary to properly effectuate any conveyance,**
34 **transfer, assignment, lease or delivery of title, excluding mineral rights, to the**
35 **property described in Section 3, and as more specifically described in any such**
36 **agreements entered into and documents executed by and between the secretary**
37 **of the Department of Health and Hospitals, the commissioner of the division of**
38 **administration, and the city of Eunice, in exchange of consideration**
39 **proportionate to the appraised value of the property.**

40 Section 5. This Act shall become effective upon signature by the governor
41 or, if not signed by the governor, upon expiration of the time for bills to become law
42 without signature by the governor, as provided by Article III, Section 18 of the

1 Constitution of Louisiana. If vetoed by the governor and subsequently approved by
2 the legislature, this Act shall become effective on the day following such approval."
