1	AN ACT
2	To enact R.S. 33:9097.12, relative to crime prevention districts; to create the Jefferson
3	Place/Bocage Crime Prevention and Improvement District in East Baton Rouge
4	Parish; to provide for the powers and duties of the district and its board of
5	commissioners; to provide for a parcel fee; to provide with respect to termination of
6	the district; and to provide for related matters.
7	Notice of intention to introduce this Act has been published.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 33:9097.12 is hereby enacted to read as follows:
10	§9097.12. Jefferson Place/Bocage Crime Prevention and Improvement District
11	A. Creation. There is hereby created within the parish of East Baton
12	Rouge, as more specifically provided in Subsection B of this Section, a body
13	politic and corporate which shall be known as the Jefferson Place/Bocage Crime
14	Prevention and Improvement District, hereinafter referred to as the "district".
15	The district shall be a political subdivision of the state as defined in the
16	Constitution of Louisiana.
17	<b>B.</b> Boundaries. The boundaries of the district shall be the areas as
18	established in the official subdivision plat filed with the clerk of court of East
19	<b>Baton Rouge Parish for the subdivisions of Bocage, Bocage Estates, Filings 1</b>
20	through 5 of Jefferson Place, and The Cloisters.
21	C. Purpose. The district is established for the purpose of promoting and
22	encouraging security in the area included within the district and promoting and
23	encouraging the beautification and overall betterment of the district.
24	D. Governance. (1) The district shall be governed by a nine-member

1	(d) Any vacancy which occurs prior to the expiration of the term for
2	which a member of the board has been appointed shall be filled for the
3	remainder of the unexpired term in the same manner as the original
4	appointment. Board members shall be eligible for reappointment.
5	(4) The board shall elect from its members a chairman, a vice chairman,
6	a secretary, a treasurer, and such other officers as it may deem necessary. The
7	duties of the officers shall be fixed by the bylaws adopted by the board.
8	(5) The minute books and archives of the district shall be maintained by
9	the secretary of the board. The monies, funds, and accounts of the district shall
10	be in the official custody of the board.
11	(6) The board shall adopt such bylaws as it deems necessary or advisable
12	for conducting its business affairs. The bylaws of the board may provide
13	relative to the publication of meeting notices and conduct of meetings. The
14	board shall hold regular meetings open to the public as shall be provided for in
15	the bylaws and may hold special meetings at such times and places within East
16	Baton Rouge Parish as may be prescribed in the bylaws. Notwithstanding any
17	other provision of law to the contrary, the district, through the board, shall give
18	notice of meetings by posting the meeting agenda at all entrances and exits to
19	Bocage subdivision at least twenty-four hours prior to the meeting and may
20	publish the meeting proceedings on the district website or in a newsletter
21	regularly distributed to district property owners.
22	(7) A majority of the members of the board shall constitute a quorum for
23	the transaction of business. The board shall keep minutes of all meetings and
24	shall make them available through the secretary of the board.
25	(8) Each member of the board shall have one vote, and the vote of a
26	majority of the members of the board present and voting, a quorum being
27	present, shall be required to decide any question upon which the board takes
28	action.
29	(9) The members of the board shall serve without compensation but shall
30	be reimbursed for their reasonable out-of-pocket expenses directly related to

15	(2) No board member or officer of the district shall be liable to the
16	district or to any individual who resides, owns property, visits, or otherwise
17	conducts business in the district for monetary damages for breach of his duties
18	as a board member or officer, provided that the foregoing provision shall not
19	eliminate or limit the liability of a board member or officer for any of the
20	following:
21	(a) Acts or omissions not in good faith or which involve intentional
22	misconduct or a knowing violation of law.
23	(b) Any transaction from which he derived an improper personal benefit.
24	(3) To the fullest extent permitted by R.S. 9:2792 et seq., including R.S.
25	9:2792.1 through 2792.9, a person serving the district as a board member or
26	officer shall not be individually liable for any act or omission arising out of the
27	performance of his duties.
28	Section 2. This Act shall become effective upon signature by the governor or, if not
29	signed by the governor, upon expiration of the time for bills to become law without signature
30	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

## PRESIDENT OF THE SENATE
