PUBLIC CONTRACT/BIDS: Provides relative to the exclusion of certain contractors from bidding on public projects

1	AN ACT
2	To amend and reenact R.S. 38:2227(A), relative to bidders on public contracts; to revise
3	provisions prohibiting certain contractors from bidding on public contracts; and to
4	provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 38:2227(A) is hereby amended and reenacted to read as follows:
7	§2227. Exclusion of certain contractors from bidding
8	A. Each public entity advertising and letting for bid a public works contract
9	shall require each the lowest bidder, in addition to the provisions of R.S.
10	38:2212(A)(3)(c)(ii), after the opening of bids, if a sole proprietor, to attest that he
11	has not been convicted of, or has not entered a plea of guilty or nolo contendere to
12	any of the crimes or equivalent federal crimes listed in Subsection B of this Section.
13	Each The lowest bidding entity shall submit an attestation that no individual partner,
14	incorporator, director, manager, officer, organizer, or member, who has a minimum
15	of a ten percent ownership in the bidding entity, has been convicted of, or has
16	entered a plea of guilty or nolo contendere to any of the crimes or equivalent federal
17	crimes listed in Subsection B of this Section.

Abstract: Revises provisions prohibiting certain contractors from bidding on public contracts.

<u>Present law</u> provides that each bidder, if a sole proprietor, shall attest that he has not been convicted of, or has not entered a plea of guilty or nolo contendere to any of the crimes or equivalent federal crimes listed in present law.

<u>Present law</u> also provides that each bidding entity shall submit an attestation that no individual partner, incorporator, director, manager, officer, organizer, or member, who has a minimum of a 10% ownership in the bidding entity, has been convicted of, or has entered a plea of guilty or nolo contendere to any of the crimes or equivalent federal crimes listed in <u>present law</u>.

<u>Proposed law</u> limits the attestation submission to the lowest bidder or bidding entity.
