HOUSE BILL NO. 1054

BY REPRESENTATIVE HILL

HIGHWAYS: Provides for the designation of certain byways

1 AN ACT

2 To enact R.S. 56:1948.5(57)(f) through (l), and (62)(b) through (l), and (64), relative to  
3 Louisiana Byways designation, to provide for route additions; and to provide for  
4 related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 56:1948.5(57)(f) through (l), (62)(b) through (l), and (64) are hereby  
7 enacted to read as follows:

8 §1948.5. Louisiana Byways designations

9 The following highways and sections of highways are hereby designated as  
10 Louisiana Byways:

12 (57) Myths and Legends Byway:

14 (f) LA 10 in Pitkin, in Vernon Parish, then west on LA 399 to Fullerton Park.

15 (g) LA 10 in Pitkin, in Vernon Parish, then northwesterly along LA 458 to  
16 LA 399 to Fullerton Park.

17 (h) From the intersection of LA 10 and LA 113 in Pitkin, in Vernon Parish,  
18 then west on LA 10 to the intersection of US 171 in Pickering of Vernon Parish.

19 (i) From the intersection of LA 10 and US 171 in Pickering, in Vernon  
20 Parish, south to the intersection of LA 190 and US 171.

1                   (j) From the intersection of LA 112 and US 171 in Deridder, in Beauregard  
2                   Parish, south to the intersection of US 171 and LA 26.

3                   (k) From LA 26 east along LA 26 to the intersection of LA 26 and US 165  
4                   in Oberlin, in Allen Parish.

5                   (l) From the intersection of LA 26 and US 165 in Oberlin, in Allen Parish,  
6                   south on US 165 to the intersection of US 165 and US 190 in Kinder, in Allen Parish.

8                   (62) Wetlands Cultural Trail (formerly known as the Lafourche/Terrebonne  
9                   Scenic Byway):

11                   (b) LA 1 from the Assumption-Lafourche Parish line to the intersection of  
12                   LA 3090, including the routing through Thibodaux, Raceland, Lockport, Larose, Cut  
13                   Off, Galliano, and Golden Meadow, and the elevated portion north of LA 3090.

14                   (c) LA 308 from the Assumption-Lafourche parish line to the intersection  
15                   of LA 1 north of Golden Meadow, including the routing through Thibodaux,  
16                   Raceland, Lockport, Larose, Cut Off, and Galliano.

17                   (d) LA 304 from its intersection with LA 308 to the intersection with LA 20.

18                   (e) LA 20 from its intersection with LA 304 to its intersection with LA 307,  
19                   including its routing through Chackbay.

20                   (f) LA 307 from its intersection with LA 20 to its intersection with LA 182,  
21                   including its routing through Kraemer.

22                   (g) LA 182 from its intersection with LA 307 to its intersection with LA 308.

23                   (h) LA 20 from its intersection with LA 1 to its intersection with LA 24.

24                   (i) LA 24 from its intersection with LA 20 south of Thibodaux to its  
25                   intersection with LA 1 in Larose, including its routing through Houma and its East  
26                   and West one-way pairs.

27                   (j) LA 56 from its intersection with LA 24 east of Houma to its terminus at  
28                   Cocodrie, including its routing through Chauvin.

- 1                   (k) LA 57 from its intersection with LA 24 in Houma south to its intersection
- 2                   with LA 56, including its routing through Dulac.
- 3                   (l) LA 182 from its intersection with LA 24 in Houma to its intersection with
- 4                   LA 20 west of Gibson.

- 6                   (64) Southern Swamp Byway: The byway corridor runs northeast of
- 7                   Interstate 10, South of Interstate 12 and adjacent to Interstate 55 in Ascension,
- 8                   Livingston, Tangipahoa, and St. John the Baptist parishes of eastern Louisiana for
- 9                   a total of 67 miles. The byway is designated on LA 22 from its intersection with LA
- 10                  70 at the Ascension Parish Visitor Center to the intersection of LA 22 with US 51-X
- 11                  in Ponchatoula and then south on US 51-X and continuing on US 51 to the Byway's
- 12                  intersection with I-10.
