HOUSE BILL NO. 16

BY REPRESENTATIVE DIXON AND SENATOR GALLOT AND REPRESENTATIVE HAZEL

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

PROPERTY/PUBLIC: Provides for transfer of certain state property in Rapides Parish to the city of Pineville

1 AN ACT

2 To authorize and provide for the transfer of certain state property; to authorize the transfer
3 of certain state property in Rapides Parish; to provide for the property descriptions;
4 to provide for reservation of mineral rights; to provide terms and conditions; to
5 provide an effective date; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. The secretary of the Department of Health and Hospitals, notwithstanding
8 any other provision of law to the contrary, is hereby authorized and empowered to convey,
9 transfer, assign, lease or deliver any interest, excluding mineral rights, the state may have
10 to all or any portion of the following described parcels of property to the city of Pineville:

11 Tract 1

12 A certain piece, parcel or lot of ground, together with all improvements thereon, rights, ways
13 and privileges thereunto belonging or in any way appertaining, being, lying and situated in
14 the Section 17, Township 4 North, Range 1 West, Rapides Parish, Louisiana, being more
15 particularly described as follows, to wit:

16 Commencing at a 4" x 4" concrete monument marking the northwest corner of the city of
17 Pineville's Wastewater Treatment Facility tract; thence proceed South 39 degrees 05 minutes
18 29 seconds West, grid bearing, along the northwest boundary line of said city of Pineville
19 tract, a distance of 371.23 feet to a 5/8" diameter iron rod (set) marking the POINT OF
20 BEGINNING of the tract be described;

21 thence continue South 39 degrees 05 minutes 29 seconds West, along said northwest
22 boundary line, a distance of 693.37 feet to a 3/4" diameter iron rod (found) marking the
23 southwest corner of said city of Pineville Wastewater Treatment Facility tract; thence
24 continue South 39 degrees 05 minutes 29 seconds West, along an extension of said
25 northwest boundary line and crossing the Red River Levee, a distance of 275.82 feet to a
26 5/8" diameter iron rod (set); thence turn right and proceed North 38 degrees 30 minutes 43
27 seconds West, departing said northwest boundary line extension, a distance of 88.36 feet to

1 a pk nail with shiner in asphalt pavement (set); thence turn right and proceed North 10
2 degrees 22 minutes 23 seconds West, a distance of 226.13 feet to a 5/8" diameter iron rod
3 (set); thence turn right and proceed North 03 degrees 12 minutes 43 seconds East, a distance
4 of 911.96 feet to a 5/8" diameter iron rod (set); thence turn right and proceed South 86
5 degrees 46 minutes 58 seconds East, a distance of 465.08 feet to a 5/8" diameter iron rod
6 (set); thence turn right and proceed South 24 degrees 18 minutes 32 seconds East, a distance
7 of 465.00 feet to the POINT OF BEGINNING;

8 The above described tract contains 12.299 acres, more or less, and is more particularly
9 indicated as Tract 1 on Pan American Engineers - Alexandria, Inc., Drawing No. 12089,
10 dated November 2, 2012.

11 Tract 2

12 A certain piece, parcel or lot of ground, together with all improvements thereon, rights, ways
13 and privileges thereunto belonging or in any way appertaining, being, lying and situated in
14 the Section 17, Township 4 North, Range 1 West, Rapides Parish, Louisiana, being more
15 particularly described as follows, to wit:

16 Commencing at a 4" x 4" concrete monument marking the northwest corner of the city of
17 Pineville's Wastewater Treatment Facility tract; thence proceed South 39 degrees 05 minutes
18 29 seconds West, grid bearing, along the northwest boundary line of said city of Pineville
19 tract, a distance of 204.78 feet to a 5/8" diameter iron rod (set) marking the POINT OF
20 BEGINNING of the tract be described;

21 thence continue South 39 degrees 05 minutes 29 seconds West, along said northwest
22 boundary line, a distance of 166.45 feet to a 5/8" diameter iron rod (set); thence turn right
23 and proceed North 24 degrees 18 minutes 32 seconds West, departing said northwest
24 boundary line, a distance of 133.37 feet to a 5/8" diameter iron rod (set); thence turn right
25 and proceed North 87 degrees 15 minutes 46 seconds East, a distance of 160.05 feet to the
26 POINT OF BEGINNING;

27 The above described tract contains 0.228 acres, more or less, and is more particularly
28 indicated as Tract 2 on Pan American Engineers - Alexandria, Inc., Drawing No. 12089,
29 dated November 2, 2012.

30 Section 2. The secretary of the Department of Health and Hospitals is hereby
31 authorized to enter into such agreements, covenants, conditions, and stipulations and to
32 execute such documents as necessary to properly effectuate any conveyance, transfer,
33 assignment, lease or delivery of title, excluding mineral rights, to the properties described
34 in Section 1, and as more specifically described in any such agreements entered into and
35 documents executed by and between the secretary of the Department of Health and Hospitals
36 and the city of Pineville, in exchange of consideration proportionate to the appraised value
37 of the property.

38 Section 3. This Act shall become effective upon signature by the governor or, if not
39 signed by the governor, upon expiration of the time for bills to become law without signature
40 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

- 1 vetoed by the governor and subsequently approved by the legislature, this Act shall become
2 effective on the day following such approval.
