APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgments against the Department of Transportation and Development in the matter of "Keith Phillips v. Pattie K. Inzenga, et al" consolidated with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-  
3 2014 to be used to pay the consent judgments against the Department of  
4 Transportation and Development in the suit entitled "Keith Phillips v. Pattie K.  
5 Inzenga, et al" consolidated with "Robert H. Fuqua, et al v. City-Parish of Baton  
6 Rouge"; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. The sum of Forty Thousand Eight Hundred Forty and No/100  
9 (\$40,840.00) Dollars, in favor of plaintiff, Hunter Fuqua, Jr., is hereby appropriated out of  
10 the General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
11 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
12 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25  
13 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
14 of East Baton Rouge, state of Louisiana.

15 Section 2. The sum of Thirty-Five Thousand Two Hundred Ninety-Four and No/100  
16 (\$35,294.00) Dollars, in favor of plaintiff, Daniel P. Lemoine, is hereby appropriated out of  
17 the General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
18 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
19 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25

1 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
2 of East Baton Rouge, state of Louisiana.

3 Section 3. The sum of Thirty-Five Thousand Two Hundred Ninety-Four and No/100  
4 (\$35,294.00) Dollars, in favor of plaintiff, Patty Hebert Lemoine Haddad, is hereby  
5 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2013-2014 to  
6 be used to pay the consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga,  
7 et al" consolidated with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing  
8 Numbers 508,512-25 and 509,248-24, respectively, on the docket of the Nineteenth Judicial  
9 District Court, parish of East Baton Rouge, state of Louisiana.

10 Section 4. The sum of Fifty-Six Thousand Seven Hundred Twenty-Four and No/100  
11 (\$56,724.00) Dollars, in favor of plaintiff, Glenda Pearson, is hereby appropriated out of the  
12 General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
13 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
14 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25  
15 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
16 of East Baton Rouge, state of Louisiana.

17 Section 5. The sum of Thirty-Five Thousand Two Hundred Ninety-Four and No/100  
18 (\$35,294.00) Dollars, in favor of plaintiff, Gerald Inzenga, is hereby appropriated out of the  
19 General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
20 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
21 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25  
22 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
23 of East Baton Rouge, state of Louisiana.

24 Section 6. The sum of Thirty-Five Thousand Two Hundred Ninety-Four and No/100  
25 (\$35,294.00) Dollars, in favor of plaintiff, Patti Inzenga, is hereby appropriated out of the  
26 General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
27 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
28 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25  
29 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
30 of East Baton Rouge, state of Louisiana.

1           Section 7. The sum of Thirty Thousand Six Hundred Thirty and No/100  
2 (\$30,630.00) Dollars, in favor of plaintiff, Vaughn Ross, Jr., is hereby appropriated out of  
3 the General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
4 consent judgment in the suit entitled "Keith Phillips v. Pattie K. Inzenga, et al" consolidated  
5 with "Robert H. Fuqua, et al v. City-Parish of Baton Rouge", bearing Numbers 508,512-25  
6 and 509,248-24, respectively, on the docket of the Nineteenth Judicial District Court, parish  
7 of East Baton Rouge, state of Louisiana.

8           Section 8. This Act shall become effective on July 1, 2013; if vetoed by the governor  
9 and subsequently approved by the legislature, this Act shall become effective on July 1,  
10 2013, or on the day following such approval by the legislature, whichever is later.
