AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-3 2014 to be used to pay the consent judgment in the suit entitled "Vincent Randolph 4 on behalf of his minor children Heather, Hezekiah, Randolph and the Estate of 5 Gwendolyn Randolph, and Dederrick Ruffin v. City of Baton Rouge, Parish of East 6 Baton Rouge ("City-Parish"), the State of Louisiana through the Department of 7 Transportation and Development and Liberty Insurance Company"; to provide for 8 court costs; and to provide for related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. The sum of Sixty-Five Thousand and No/100 (\$65,000.00) Dollars, plus 11 court costs in the amount of One Thousand Four Hundred Sixty-One and 49/100 (\$1,461.49) 12 Dollars, is hereby appropriated out of the General Fund of the state of Louisiana for Fiscal 13 Year 2013-2014 to be used to pay the consent judgment in the suit entitled "Vincent 14 Randolph on behalf of his minor children Heather, Hezekiah, Randolph and the Estate of 15 Gwendolyn Randolph, and Dederrick Ruffin v. City of Baton Rouge, Parish of East Baton 16 Rouge ("City-Parish"), the State of Louisiana through the Department of Transportation and 17 Development and Liberty Insurance Company", bearing Number 566335 on the docket of 18 the Nineteenth Judicial District Court, parish of East Baton Rouge, state of Louisiana.
