HOUSE BILL NO. 403

APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the Department of Transportation and Development in the matter of "James Brinson, Jr., et al v. State of Louisiana"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-  
3 2014 to be used to pay the consent judgment in the suit entitled "James T. Brinson,  
4 Jr., et al v. State of Louisiana"; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. The sum of Two Hundred Fourteen Thousand Six Hundred Fifty and  
7 No/100 (\$214,650.00) Dollars is hereby appropriated out of the General Fund of the state  
8 of Louisiana for Fiscal Year 2013-2014 to be used to pay the consent judgment in the suit  
9 entitled "James T. Brinson, Jr., et al v. State of Louisiana", bearing Number C-504-99 on the  
10 docket of the Thirty-First Judicial District Court, parish of Jefferson Davis, state of  
11 Louisiana.

12 Section 2. The sum of Four Thousand Eight Hundred Thirty-One and 15/100  
13 (\$4,831.15) Dollars is hereby appropriated out of the General Fund of the state of Louisiana  
14 for Fiscal Year 2013-2014 to be paid to the Department of Health and Hospitals for  
15 Medicaid reimbursement in the suit entitled "James T. Brinson, Jr., et al v. State of  
16 Louisiana", bearing Number C-504-99 on the docket of the Thirty-First Judicial District  
17 Court, parish of Jefferson Davis, state of Louisiana.

18 Section 3. This Act shall become effective on July 1, 2013; if vetoed by the governor  
19 and subsequently approved by the legislature, this Act shall become effective on July 1,  
20 2013, or on the day following such approval by the legislature, whichever is later.
