AN ACT

2 To amend and reenact R.S. 23:1371.2, relative to workers' compensation; to provide for the 3 submission deadlines to the Workers' Compensation Second Injury Fund; to extend 4 the sunset date of the fund; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: Section 1. R.S. 23:1371.2 is hereby amended and reenacted to read as follows: 6 7 §1371.2. Sunset of the fund 8 No claim shall be submitted for board approval with a date of accident after 9 December 31, 2014 2019, and all submissions of documentation to support pending 10 claims shall be presented to the board on or before December 31, 2016 2021. The 11 board shall render a decision of approval or denial on pending claims on or before 12 December 31, 2017 2022. Reimbursement from the Second Injury Fund shall 13 continue to be processed as set forth in R.S. 23:1378(A) until all claims are closed.

**Abstract:** Extends the sunset date of the Workers' Compensation Second Injury Fund.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Present law</u> creates the Second Injury Board and Second Injury Fund to encourage the employment, re-employment, or retention of employees who have a permanent, partial disability.

<u>Present law</u> provides that no claim shall be submitted for board approval with a date of accident after Dec. 31, 2014.

<u>Proposed law</u> changes the date for submission for the board with a date of accident <u>from</u> Dec. 31, 2014 to Dec. 31, 2019.

<u>Present law</u> requires that all submissions of documentation to support pending claims shall be presented to the board on or before Dec. 31, 2016.

<u>Proposed law</u> changes the date for submission of documentation to support pending claims <u>from</u> Dec. 31, 2016 to Dec. 31, 2021.

<u>Present law</u> requires the board to render a decision on pending claims on or before Dec. 31, 2017.

Proposed law changes the date for decisions on claims from Dec. 31, 2017, to Dec. 31, 2022.

<u>Present law</u> provides that reimbursement from the fund shall continue to be processed until all claims are closed.

<u>Proposed law</u> retains <u>present law</u>.
