A CONCURRENT RESOLUTION

2	To recognize July 2013 as "Swimming Pool Safety Month" in honor of Aubrie and Angel
3	Castine-Smith.
4	WHEREAS, during the summer of 2012, Aubrie and Angel Castine-Smith, twin girls
5	from the city of Bossier, lost their lives in a swimming pool drowning accident; and
6	WHEREAS, approximately ten people die from unintentional drowning everyday in
7	the United States, and of these victims, two are children aged 14 or younger; and
8	WHEREAS, drowning ranks fifth among the leading causes of unintentional death
9	in the United States; and
10	WHEREAS, the Centers for Disease Control and Prevention provides that the main
11	factors that affect drowning risk are lack of swimming ability, lack of barriers to prevent
12	unsupervised water access, lack of supervision while swimming, location, failure to wear life
13	jackets, alcohol use, and seizure disorders; and
14	WHEREAS, one precaution, a four-sided isolation fence, reduces a child's risk of
15	drowning by 83% compared to three-sided property-line fencing; and
16	WHEREAS, water safety awareness and education are essential for preventing
17	drowning and other water-related injuries; and
18	WHEREAS, it is important to encourage all citizens who participate in aquatic-
19	related recreational activities to recognize and adhere to water safety rules and programs
20	established by law enforcement, swimming facilities, public and private waterfronts, water
21	parks, home pools and spas, and all other locations where water-related activities may occur.
